**RESOLUTION AUTHORIZING TAX APPEAL SETTLEMENT REGARDING
RIVERHOUSE ASSOCIATES LLC, 49 RIVERSIDE AVENUE, BLOCK 6, LOT 7, RED
BANK, NEW JERSEY**

WHEREAS, the plaintiff, Riverhouse Associates LLC, appealed to the Tax Court of the State of New Jersey under Docket Nos. 008534-2012, 003307-2013, and 003777-2014 pertaining to tax assessments for the 2012, 2013, and 2014 tax years on property designated on the municipal tax records as Block 6, Lot 7, and with an address of 49 Riverside Avenue, Red Bank, New Jersey; and

WHEREAS, the Assessor and the Attorney have advised the Governing Body that they, along with the Borough’s valuation expert, have carefully considered the appeal and upon reviewing all the facts and based upon appropriate adjustments of fair market value that they recommend settlement providing for the settlement of the aforementioned appeals as follows:
