5. APPLICANT MUST RETURN COMPLETED APPLICATION WITH PHOTOGRAPHS & ABSTRACT TO THE RED BANK POLICE DEPARTMENT. THE BOROUGH OF RED BANK CHARGES A \$30.00 FILING FEE.
6. APPLICANT MUST BE FINGERPRINTED AT THE RED BANK POLICE DEPARTMENT RECORDS BUREAU.

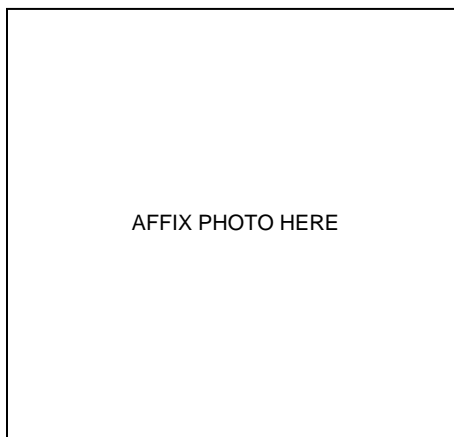
