**INSTRUCTIONS TO APPLICANT:**

1. Applicant must complete all questions.
2. Applicant must have application notarized by a NJ Notary Public.
3. Applicant must return application to Borough Clerk and pay fee at 90 Monmouth Street.
4. Applicant must bring application to Police Dept., 90 Monmouth Street, (Records Bureau), to be fingerprinted.
5. If not engaged solely in his own behalf, a letter from employer or person under whose auspices applicant seeks to act, must be attached.
6. Sample copy or copies of order forms, receipt forms and any other forms to be used by applicant in connection with his proposed activity, must be attached.

**SUPPLEMENT TO APPLICATION WHERE APPLICATION IS FOR TRANSIENT MERCHANT LICENSE.**

There must be attached to the application the following:

1. A sworn statement of the true invoice of the amount, average quality or kind and value of the goods to be offered for sale.
2. A statement of the location of such goods by street or number and whether on the premises from which it is sold or in ware house.
3. The bills or invoice of purchase of goods to be offered for sale.
4. If Section VI (a) is applicable, declaration required under Paragraph I thereof.
5. If Section VI is applicable, Bond required under Paragraph (a) 2 thereof.

**SUPPLEMENT TO APPLICATION WHERE APPLICATION IS FOR TRANSIENT MERCHANT PEDDLER LICENSE.**

There must, in addition to the additional items required in the application for a Transient Merchant License, be furnished the following:

1. The name and address of each peddler acting for said merchant.
2. Application form required for all applicants for each peddler acting for said merchant.

**SUPPLEMENT TO APPLICATION WHERE APPLICANT IS LOCAL CHAIRMAN OR OTHER PERSON IN CHARGE OF SOLICITATION IN BEHALF OF RELIGIOUS OR CHARITABLE ORGANIZATION.**

Attach to application the following:

1. List of names and addresses of all person to be authorized to solicit for such organization for the period of the license.
2. Form of identification card to be carried by each person to engage in such solicitation.

**NOTE:** Each identification card must be signed by the Applicant, except where solicitation is to be performed by children under the age of 19 who reside in the Borough of Red Bank, in which case the identification card may be signed by any member of the Committee in charge of sale solicitation for such local school or church, provided that the Chairman thereof has filed the signatures of such Committee members with and as a part of the application for license made by such Chairman.
