**RESOLUTION AWARDING CONTRACT FOR SPONSORSHIP AND PROMOTION FOR THE  
2008 RED BANK SUMMER SERIES, PRODUCED BY THE RED BANK PARKS &  
RECREATION DEPARTMENT**

**WHEREAS**, on Wednesday, March 19, 2008, the Borough of Red Bank received one (1) bid for the Sponsorship and Promotion for the 2008 Red Bank Summer Series, Produced by the Red Bank Parks & Recreation Department; and

**WHEREAS**, Spark Market Solutions, LLC, 31 Maple Avenue, Little Silver, NJ 07739 submitted the sole responsible bid as follows:

1. 9% of gross sponsorship revenue will be dedicated by Spark to production of summer publication;
2. 30% commission on net value of cash sponsorship (gross sponsorship revenue minus 9% summer publication allocation) (excluding Comcast and Brookdale Public Radio 90.5 The Night); and
3. 10% on cash value of qualified barter sponsorships (excluding Comcast and 90.5 The Night).

**WHEREAS**, the Purchasing Agent has found the paperwork to be in order recommends award to the sole responsible bidder, Spark Market Solutions, LLC, 31 Maple Avenue, Little Silver, NJ 07739; and

**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and Council of the Borough of Red Bank that the contract for the Sponsorship and Promotion of the 2008 Red Bank Summer Series, Produced by the Red Bank Parks & Recreation Department, be and same is hereby awarded to Spark Market Solutions, 31 Maple Avenue, Little Silver, NJ 07739;

**BE IT FURTHER RESOLVED** that the Mayor and Clerk are requested and authorized to sign and deliver a contract on behalf of the Borough of Red Bank;

**BE IT FURTHER RESOLVED** that the Borough Clerk forward a certified copy of this resolution to the Purchasing Agent to send with contracts to Spark Market Solutions.
