Mayor Menna said they would hold off on the presentation of the proclamations until Councilwoman Horgan was present.

PUBLIC COMMENT (AGENDA ITEMS ONLY)

Glenn Carter—Executive Director of RiverCenter—said he was speaking on the Broad Street project. He reviewed the issues with the project and reviewed who he felt should bear the responsibility for the cost. He also reviewed the Borough's policy and past practices. He said he felt the Borough should pay.

Stephen Hecht—135 Branch Avenue—said he wanted to speak regarding Resolution 21-334 to create a Plan Endorsement Committee. He noted vacancies for key Borough personnel and possible changes under discussion by various boards. He said he was suggesting that the resolution be tabled until some of the issues were resolved, particularly the Charter Study.

Councilwoman Horgan joined the meeting at 6:37pm.

William Poku—90 Bank Street—said he felt the Borough was a hostile work environment for black employees. He brought up two employees who were slated to retire.

Mayor Menna interrupted him to notify him that the Council could not discuss personnel matters.

Mr. Poku continued with his comments regarding the retirements and said he believed they had been forced to retire. He said he also wanted to speak regarding Resolution 21-330 regarding the acceptance of an electric vehicle. He said he felt the donation should be rejected because the vehicle was out of warranty. He suggested other places where the vehicle could be donated. He also commented on the issue of hybrid meetings and asked why no one had reached out to a resident who had offered her services.

Councilman Ballard thanked Director Ebanks for re-writing Resolution 21-334 and asked how many people currently sat on the Green Team because he believed the Plan Endorsement Committee was limited to 10 members.

Councilwoman Triggiano said she was not sure how many people current sat on the Green Team but said she understood from the State that the Green Team was just the organizing tool to bring people together that would serve on the Planning Advisory Committee. She said she did not believe there was an issue with the number of people on the Green Team in regard to the Plan Endorsement Committee.

A discussion followed regarding the language of the resolution.

Clerk Borghi confirmed that there were seven full members of the Environmental Commission and three proposed members for the Green Team which would total 10.

Councilman Zipprich asked if that included the Creative Team and if it was a subcommittee of the Green Team.

Clerk Borghi said that was separate from the Green Team and said both were subcommittees of the Environmental Commission.

Councilman Zipprich asked about a resolution done earlier in the year to designate Environmental Commission members as members of the subcommittee.

Clerk Borghi said the resolution authorized the seven full members of the Environmental Commission to be members of the Green Team but said they had nothing to do with the Creative Team.

Councilwoman Triggiano said that was correct.

Councilwoman Triggiano offered a motion to approve the resolutions en masse, seconded by Councilman Yngstrom.

Councilman Ballard thanked the DPW employees for their years of service. He said the DPW had been depleted over the years. He said their leaving was bittersweet and he wished them the best. He extended his appreciation his Council colleagues, the Borough employees, Board/Committees and residents.

Councilwoman Triggiano said she wanted to congratulate the Environmental Commission and the Borough on achieving Silver Certification with the Sustainable Jersey Program.

Councilman Zipprich also reported that the Historic Preservation Commission was working on the assessment of Rector Place as a Historic District. He also provided an Information Technology update.

Councilman Yassin had no report.

Councilwoman Horgan said Councilman Ballard had been every eloquent and agreed with his comments. She reported that the Parks & Recreation Johnny Jazz Park tree lighting had gone very well and reviewed other winter programs. She also reported on upcoming activities at the Library.

Councilwoman Triggiano noted this was Councilman Yassin's last meeting and thanked him for his service and for always being accessible.
