**RESOLUTION AUTHORIZING AN AMENDMENT TO THE DEVELOPMENT AGREEMENT  
WITH THE RED BANK AFFORDABLE HOUSING CORPORATION AND THE HOUSING  
AUTHORITY OF THE BOROUGH OF RED BANK**

Ms. Lee offered the following resolution and moved its adoption:

**WHEREAS**, on July 31, 2008, the parties designated above entered into a Development Agreement with the Borough of Red Bank setting forth the rights and responsibilities of each party with respect to the construction of a one-hundred percent affordable housing project known as "Cedar Crossing"; and

**WHEREAS**, the Red Bank Affordable Housing Corporation (RBAHC) has secured financing of about \$5,000,000.00 for the construction of the Cedar Crossing project from Investors' Savings Bank and the New Jersey Housing and Mortgage Finance Agency (HMFA); and

**WHEREAS**, the parties wish to modify the aforementioned Development Agreement to set forth the parties' rights and responsibilities in the event that the RBAHC defaults upon its responsibilities under either the Development Agreement, or under the terms and conditions of the financing agreements among the RBAHC, Investors Savings and the HMFA; and

**WHEREAS**, it is the intent of this agreement that if the RBAHC defaults on any of its agreements, said financing will be made available to the Borough, or its assignee, to complete the project, in cooperation with Investors Savings and the HMFA

**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and Council of the Borough of Red Bank of Red Bank that the Mayor and the Borough Clerk are hereby authorized to execute the First Amendment to the Development Agreement for the Cedar Crossing Affordable Housing Project;

**BE IT FURTHER RESOLVED** that this Amendment to the Development agreement shall be subject to review and approval by the Borough Attorney;
