

ORDINANCE NO. 2009-13

ORDINANCE OF THE BOROUGH OF RED BANK,  
COUNTY OF MONMOUTH, NEW JERSEY  
AMENDING AND SUPPLEMENTING  
CHAPTER III, POLICE REGULATIONS  
SECTION 3-9, "DISORDERLY PERSONS"

**WHEREAS**, the Mayor and Council of the Borough of Red Bank believe that it is appropriate to increase the Borough's minimum fines for certain Disorderly Persons violations to make them consistent with other Monmouth County municipalities;

**NOW, THEREFORE, BE IT ORDAINED** by the Governing Body of the Borough of Red Bank that Chapter III of the Revised General Ordinances of the Borough of Red Bank, Monmouth County, "Police Regulations" is hereby amended and supplemented as follows:

**SECTION ONE:**

Section 3-9, "Disorderly Persons" is hereby amended and supplemented as follows (stricken text denotes deletions, underlined text denote additions):

**3-9 DISORDERLY PERSONS.**

**3-9.1 Disorderly House Unlawful.** *[No change ...]*

**3-9.15 Minimum Fines for Violations.** Unless a different fine or penalty is specified in any of the foregoing subsections of this Section 3-9, any person violating any of the provisions of this Section shall, upon conviction thereof, be subject to a minimum fine of no less than two hundred and fifty (\$250.00) dollars. The maximum fine, and any authorized periods of imprisonment shall be as set forth in the General Penalty provision at Section 1-5 of this Code, as it may exist from time to time.

**SECTION TWO:** Any ordinances or portions thereof which are inconsistent with the provisions of this Ordinance are hereby repealed as of the effective date of this Ordinance. All other provisions of the Revised General Ordinances are ratified and remain in full force and effect.

**SECTION THREE:** If any provision of this Ordinance or the application of such provision to any person or circumstance is declared invalid, such invalidity shall not affect the other

provisions or applications of this Ordinance which can be given effect, and to this end, the provisions of this Ordinance are declared to be severable.

**SECTION FOUR:** This Ordinance shall take effect immediately upon its passage and adoption according to law.
