**RESOLUTION NO. 08-178**

**A RESOLUTION AUTHORIZING RELEASE OF PERFORMANCE GUARANTEES AND  
ACCEPTING A MAINTENANCE GUARANTEE REGARDING  
20 WHITE STREET, L.L.C. FOR 20 WHITE STREET, BLOCK 30.01, LOT 38**

Ms. Lee offered the following resolution and moved its adoption:

**WHEREAS**, by Resolution 07-144, the Borough of Red Bank accepted Performance Guarantees from 20 White Street, L.L.C. for a development project located at 20 White Street; and

**WHEREAS**, in accordance with that prior resolution, 20 White Street, L.L.C. posted, and the Borough accepted, a cash performance guarantee in the sum of \$18,980.00, plus an inspection escrow fee in the sum of \$800.00; and

**WHEREAS**, 20 White Street, L.L.C. has requested that the Borough release the above-describe performance guarantee; and

**WHEREAS**, 20 White Street, L.L.C. has further requested that the Borough retain the sum of \$1,898.00 from the aforementioned cash performance guarantee as a two-year maintenance guarantee; and

**WHEREAS**, in a report dated July 14, 2008, the Borough Engineer recommended that the performance guarantee be released and a maintenance guarantee be retained;

**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and Council of the Borough of Red Bank that it does hereby release the previously posted performance guarantee under the following conditions:

1. The Borough shall retain the sum of \$1,898.00 in cash as a maintenance guarantee;
2. The Borough shall release the sum of \$17,082.00, which is the balance of the previously posted performance guarantee less the aforementioned cash maintenance guarantee retained by the Borough; and
3. 20 White Street, L.L.C. post the sum of \$500.00 for inspection fees related to the future release of the above-described maintenance guarantee.

**BE IT FURTHER RESOLVED** that the Chief Financial Officer and the Director of Planning and Zoning are authorized and requested to take appropriate steps to implement this resolution; and

**BE IT FURTHER RESOLVED** that the Borough Clerk shall forward certified true copies of this resolution to the Borough Engineer, the Director of Planning and Zoning, the Chief Financial Officer and to 20 White Street, L.L.C., c/o Martin A. McGann, Jr., Esq., 125 State Hwy. 35, Red Bank, New Jersey 07701
