RESOLUTION NO. 08-260

**RESOLUTION AUTHORIZING THE MAYOR AND THE BOROUGH CLERK TO EXECUTE AN
INTER-LOCAL SERVICES AGREEMENT WITH
THE BOROUGH OF FAIR HAVEN FOR TAX COLLECTION SERVICES**

Mr. DuPont offered the following resolution and moved its adoption:

WHEREAS, the Borough of Red Bank and the Borough of Fair Haven seek to continue an Interlocal Services Agreement with respect to the collection of taxes within those two municipalities; and

WHEREAS, the Borough of Red Bank's and the Borough of Fair Haven's present Tax Collector, Ms. Dale Connor, is qualified and available to serve as the Red Bank Tax Collector, and

WHEREAS, there will be significant cost savings to the Borough of Red Bank by sharing Ms. Connor's services with the Borough of Fair Haven;

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the Borough of Red Bank that the Mayor and the Borough Clerk are hereby authorized to execute an renewed Inter-Local Services Agreement with the Borough of Fair Haven for Tax Collection Services under the following general terms:

- a. The Inter-Local Services Agreement shall be for 3 years; terminable by either party on six months notice;
- b. The Borough of Red Bank shall pay the Borough of Fair Haven in accordance with the following schedule:
 - (a) \$5,788.12 for Tax Collector services for the year 2009 plus fica of \$442.79;
 - (b) The annual payment shall be adjusted on the second and third anniversary of the agreement by five percent (5%), as follows:
 - (1) 2010 – \$6,077.53 plus fica \$464.93;
 - (2) 2011 – \$6,381.41 plus fica \$488.18.
- c. The Borough of Red Bank shall not be responsible for any other compensation, or benefits, to Ms. Connor other than the above-mentioned annual payment to the Borough of Red Bank; and
- d. Ms. Connor shall serve the Borough of Red Bank on an as-needed basis, but no less than two hours per week.

BE IT FURTHER RESOLVED that the Mayor and the Borough Clerk are authorized to sign any documents necessary to effectuate this Resolution; and

BE IT FURTHER RESOLVED that the Clerk forward certified true copies of this resolution to the Clerk of the Borough of Fair Haven, 748 River Road, Fair Haven, New Jersey 07704.
