**ORDINANCE OF THE BOROUGH OF RED BANK,
COUNTY OF MONMOUTH, NEW JERSEY
AMENDING AND SUPPLEMENTING
CHAPTER VII, "TRAFFIC,"
SECTION 7-6.1, SCHEDULE VII, "THROUGH STREETS," and
SECTION 7-6.2, SCHEDULE VIII "STOP INTERSECTIONS"**

BE IT ORDAINED by the Governing Body of the Borough of Red Bank that Chapter VII of the Revised General Ordinances of the Borough of Red Bank, Monmouth County, "TRAFFIC," Sections 7-6.1, Schedule VII, "Through Streets", and 7-6.2, Schedule VIII, "Stop Intersections" is hereby amended and supplemented as follows:

SECTION ONE:

a. Section 7-6.1, Schedule VII, "Stop Intersections" is amended and supplemented as follows:

SCHEDULE VII

THROUGH STREETS

In accordance with the provisions of Subsection 7-6.1, the following described streets or parts of streets are hereby designated as Through Streets. STOP signs shall be installed on the near right side of each street intersecting the Through Street except where YIELD RIGHT-OF-WAY signs are provided for in the designation:

Bergen Place

- a. Between Branch Avenue and Broad Street.
- b. Between Broad Street and Maple Avenue

Bridge Avenue

- a. Between Newman Springs Road and Drs. James Parker Boulevard (West Bergen Place).
- b. Between Drs. James Parker Boulevard (West Bergen Place) and ~~Riverside Avenue~~ ~~Herbert Street~~.
- c. Between Oakland Street and Riverside Avenue

b. Section 7-6.2, Schedule VIII, "Stop Intersections" is amended and supplemented as follows (strikeouts denote deletions, underlined text denotes additions):

SCHEDULE VIII

STOP INTERSECTIONS

In accordance with the provisions of Subsection 7-6.2, the following intersections are hereby designated as Stop Intersections:

Bridge Avenue and Chestnut Street:

STOP signs shall be installed on all approaches.

[All other provisions remain unchanged]

SECTION TWO: Any ordinances or portions thereof which are inconsistent with the provisions of this Ordinance are hereby repealed as of the effective date of this Ordinance.

SECTION THREE: If any provision of this Ordinance or the application of such provision to any person or circumstance is declared invalid, such invalidity shall not affect the other provisions or applications of this Ordinance which can be given effect, and to this end, the provisions of this Ordinance are declared to be severable.

SECTION FOUR: This Ordinance shall take effect immediately upon its passage and adoption according to law.
