RESOLUTION NO. 20-154**

**A RESOLUTION APPROVING A SHORT-TERM SHARED SERVICES AGREEMENT AND A LONG-TERM SHARED SERVICES AGREEMENT WITH THE MONMOUTH COUNTY BOARD OF HEALTH FOR THE PROVISION OF LOCAL PUBLIC HEALTH SERVICES**

**WHEREAS**, by Resolution dated February 12, 2020, the Borough of Red Bank, County of Monmouth, State of New Jersey (the “Borough”) terminated its Shared Services Agreement for Local Public Health Services with the Monmouth County Regional Health Commission, effective August 31, 2020; and

**WHEREAS**, there must be a board of health in every municipality in the State, whether through its own individual municipal local health agency or through another agency such as a county health department; and

**WHEREAS**, the Monmouth County Board of Health, through the Monmouth County Health Department (the “County”), provides State-mandated local health services pursuant to the Local Health Services Act, N.J.S.A. 26:3A2-1, *et seq.* and the Public Health Practice Standards of Performance for Local Boards of Health in New Jersey, N.J.A.C. 8:52-1, *et seq.*; and

**WHEREAS**, the County serves as the health department for various towns throughout Monmouth County by virtue of contractual agreements; and

**WHEREAS**, the Borough is in need of local health services as of September 1, 2020, and the County desires to provide health services to the Borough; and

**WHEREAS**, pursuant to N.J.S.A. 26:3A2-19, payment by the Borough to the County to provide local health services is determined based upon the County’s annual budget, adjusted and apportioned between participating municipalities in accordance with N.J.S.A. 54:4-49, and the total amount is assessed, levied and collected in the same manner as other County taxes; and

**WHEREAS**, because the Borough is contracting with the County mid-year for local health services, the appropriate tax assessment cannot be levied and collected as contemplated by N.J.S.A. 26:3A2-19 from September 1, 2020 to December 31, 2020; and

**WHEREAS**, the County has proposed and the Borough accepts a short-term Shared Services Agreement for pre-determined fees with the County from September 1, 2020 to December 31, 2020; and

**WHEREAS**, the County has also proposed and the Borough also accepts a long-term Shared Services Agreement for local health services, with assessments calculated pursuant to N.J.S.A. 26:3A2-19 from January 1, 2021 to December 31, 2025;

**NOW, THEREFORE, BE IT RESOLVED**, by the Governing Body of the Borough of Red Bank, County of Monmouth, State of New Jersey, that:

1. The Mayor is hereby authorized to execute: (a) the Short-Term Memorandum of Agreement with the County, attached hereto as Exhibit A; and (b) the Memorandum of Agreement with the County, attached hereto as Exhibit B, for the provision by the County to the Borough of local public health services.
2. The Chief Financial Officer has certified that funds are available for this purpose in account no(s). 0-01-27-786-298.
2. This resolution shall become effective immediately.

4. A certified copy of this resolution, together with a copy of the executed Agreement, shall be forwarded to the Borough Administrator and the Monmouth County Board of Health.
