**A RESOLUTION ACCEPTING BIDS AND AWARDING CONTRACT
FOR 2020 RED BANK ROAD PROGRAM**

WHEREAS, on August 13, 2020, bids were received for the Borough’s 2020 Red Bank Road Program, as follows:

WHEREAS, the Borough Engineer has reviewed the bids received from the aforementioned contractors; and

WHEREAS, the Borough Engineer has recommended award of the contract to the lowest responsible bidder, Fiore Paving Company, Inc. of Oceanport, New Jersey, in the amount of \$1,137,797.45 for Base Bid and Alternate Item A, as available funding permits, subject to review by the Borough Attorney; and

WHEREAS, the Borough Attorney has reviewed the award and finds same to be legally acceptable and appropriate;

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the Borough of Red Bank that the above-described bid received from Fiore Paving Company, Inc. of Oceanport, New Jersey for the Borough’s 2020 Red Bank Road Program is hereby accepted in accordance with the recommendation of the Borough Engineer and the review of the Borough Attorney.

BE IT FURTHER RESOLVED that the Mayor and Clerk are authorized and requested to sign and deliver applicable contract(s) on behalf of the Borough of Red Bank, subject to review by the Borough Attorney, including review of bid bond and surety provided by the low bidder.

BE IT FURTHER RESOLVED that the bid and bid securities of the second and third lowest bidders, Blackrock Enterprises, LLC and Lucas Brothers, Inc. shall be retained and held open, pending execution of the awarded contract by Fiore Paving Company, Inc.

BE IT FURTHER RESOLVED that the Borough Clerk forward a certified true copy of this resolution to the Borough Administrator, Borough DPU Director, Borough CFO, Borough Engineer, Fiore Paving Company, Inc., and to the unsuccessful bidders.
