

**ORDINANCE NO. 2020-16**

**ORDINANCE OF THE BOROUGH OF RED BANK, COUNTY OF MONMOUTH,  
STATE OF NEW JERSEY AMENDING THE REVISED GENERAL ORDINANCES  
OF THE BOROUGH AT SECTION 680-60: “SCHEDULE XXVI” UNDER CHAPTER 680: “PARKING  
AND TRAFFIC” TO UPDATE HANDICAPPED PARKING LOCATIONS**

**BE IT ORDAINED** by the Governing Body of the Borough of Red Bank that the Borough’s Revised General Ordinances are hereby amended at Section 680-60: “Schedule XXVI” under Chapter 680: “Vehicles and Traffic” as follows (~~stricken text deleted~~; underlined text added):

**§ 680-60 SCHEDULE XXVI: Restricted Parking for Handicapped Persons**

In accordance with the provisions of § 680-21 of this chapter, the following locations are hereby designated as restricted parking spaces for use by persons who have been issued special vehicle identification cards by the ~~Division of Motor Vehicles~~ Motor Vehicle Commission. No other person shall park in these spaces.

**A.      Parking Lots.**

English Plaza Parking Lot	First parking space on the east side and the first parking space on the west side at the south end of English Plaza parking lot
Lot #1B	At the west side of Lot 1B starting at a distance of 67 feet north of the southern driveway off Oakland Street and continuing for a distance of 164 feet (6 spaces)
Lot #1C	At the western driveway off Bridge Avenue starting a distance of 12 feet east and south and continuing for a distance of 45 feet (4 spaces)
Lot #2	At the west side of Lot #2 starting a distance of 19 feet south of the north driveway off Oakland Street and continuing for a distance of 64 feet (4 spaces)
Marine Park	At the north end of Marine Park starting at a point 150 feet where the northerly bulkhead meets the easterly bulkhead and extending west for a distance of 43 feet
Mechanic Street Parking Lot	Northernmost driveway south for a distance starting 14 feet and continuing 54 feet (2 spaces)
32 Monmouth Street	First parking space behind Municipal Building east side of parking lot (1 space)
Wallace Street Parking Lot	East side of parking lot starting a distance of 12 feet from the easternmost driveway and continuing a distance of 40 feet (1 space)
Wallace Street Parking Lot	West side of parking lot starting a distance of 12 feet north of the southern driveway and continuing northerly a distance of 30 feet (1 space)
White Street Parking Lot	North side of parking lot, easternmost driveway starting at a distance of 117 feet from driveway and continuing easterly for 160 feet (4 spaces)

Bridge Avenue	Beginning at a point 51 feet westerly of the southernmost driveway and thence continuing northerly for 30 feet (2 spaces)
7 Maple Avenue	Beginning at a point 45 feet northerly from where the westernmost driveway intersects with Maple Avenue and thence continuing northerly 30 feet (2 spaces)
90 Monmouth Street	Beginning at a point 56 feet north of the easternmost driveway and thence westerly 45 feet to a point and thence continuing westerly a distance of 69 feet (2 spaces)

Bank Street	North	<u>Beginning at a point 235 feet west of Shrewsbury Avenue and continuing for a distance of 25 feet. This space is located in front of the residence commonly known as 20 Bank Street.</u>
Bridge Avenue	East	<del>Beginning at a point 25 feet north of the intersection of Bridge Avenue and the north side of East Sunset Avenue and continuing northerly on Bridge Avenue a distance of 22 feet (handicapped parking for the benefit of the residence commonly known as 38 East Sunset Avenue)</del>
Bridge Avenue	West	Beginning at a point 25 feet north of the intersection of Bridge Avenue and the north side of East Sunset Street and continuing northerly on Bridge Avenue a distance of 45 feet (2 handicapped parking spaces in front of St. Thomas Episcopal Church)
Broad Street	East	Beginning at a point 215 feet south of the southeast intersection of Broad Street and Canal Street and thence continuing southerly a distance of 22 feet
Broad Street	East	Beginning at a point 35 feet north of the northeast intersection of Broad Street and Wallace Street and thence continuing northerly a distance of 22 feet
Broad Street	West	Beginning at a point 55 feet south of the northwest intersection of Broad Street and Front Street and thence continuing southerly a distance of 22 feet

Catherine Street (P1886492)	North	Beginning at a point 140 feet east of the northwest intersection of Catherine Street and Tilton Avenue and continuing west for a distance of 22 feet. This space is located on the street in front of the residence commonly known as 162 Catherine Street.
East Bergen Place	South	<del>In front of 181 East Bergen Place</del>
East Westside Avenue	South	In front of 25 East Westside Avenue
Leighton Avenue	East	<del>Beginning at a point 108 feet north of the intersection of Leighton Avenue and Newman Springs Road and thence running northerly along the easterly side of Leighton Avenue a distance of 35 feet (in front of the residence commonly known as 287 Leighton Avenue)</del>
Linden Place	North	<del>Beginning at a point on the north side of Linden Place located 68 feet east from the common line of tax block 43, lots 7.01 and 21, and thence continuing easterly a distance of 25 feet (in front of the residence commonly known as 43 Linden Place)</del>
Linden Place	North	Starting at a point 25 feet east of the northeast corner of Washington Street and extending 22 feet east (in front of the residence commonly known as 90A Linden Place)
Linden Place (P1561214)	North	<del>Beginning at a point 103 feet west of Washington Street continuing west for a distance of 20 feet. This space is located on the street in front of the residence commonly known as 79 Linden Place.</del>
Monmouth Street	South	Starting at a point 148 feet west of the intersection of Monmouth Street with Maple Avenue and then running westerly for a distance of 25 feet
Montgomery Terrace		<del>Beginning at a point 25 feet west of the southwest corner of Drs. James Parker Boulevard and Tilton Avenue and continuing 30 feet in a westerly direction</del>
Tilton Avenue	West	Beginning at a point 220 feet south of the intersection of Drs.

		James Parker Boulevard and Tilton Avenue and continuing on the west side of Tilton Avenue a distance of 45 feet (two handicapped parking spaces in front of 114 and 115 Montgomery Terrace)
Tilton Avenue (P1740189)	West	Beginning at a point 108 feet north of the northwest intersection of Tilton Avenue and West Bergen Place and continuing north for a distance of 22 feet. This space is located on the street in front of the residence commonly known as 58 Tilton Avenue.
Tower Hill Avenue (P1807725)	North	Beginning at a point 105 feet west of the northwest intersection of Tower Hill Avenue and Harding Road and continuing west for a distance 22 feet. This space is located on the street in front of the residence commonly known as 78 Tower Hill Avenue.
Washington Street (P1605942)	West	Beginning at a point 116 feet north of the northwest intersection of Washington Street and Linden Place and continuing north for a distance of 22 feet. This space is located on the roadway across from the residence commonly known as 85 Washington Street.
West Westside Avenue	South	<del>Starting at a point 143 feet west of the southwest intersection of Shrewsbury Avenue and West Westside Avenue and then running westerly for a distance of 20 feet (in front of the residence commonly known as 11 West Westside Avenue)</del>

**BE IT FURTHER ORDAINED** by the Governing Body of the Borough of Red Bank that any ordinances or portions thereof which are inconsistent with the provisions of this Ordinance are hereby repealed as of the effective date of this Ordinance. All other provisions of the Revised General Ordinances are ratified and remain in full force and effect.

**BE IT FURTHER ORDAINED** by the Governing Body of the Borough of Red Bank that if any provision of this Ordinance or the application of such provision to any person or circumstance is declared invalid, such invalidity shall not affect the other provisions or applications of this Ordinance which can be given effect, and to this end, the provisions of this Ordinance are declared to be severable.

**BE IT FURTHER ORDAINED** by the Governing Body of the Borough of Red Bank that this Ordinance shall take effect immediately upon its passage and adoption according to law.
