

ORDINANCE NO. 2020-17

ORDINANCE OF THE BOROUGH OF RED BANK, COUNTY OF MONMOUTH,  
STATE OF NEW JERSEY AMENDING THE REVISED GENERAL ORDINANCES  
OF THE BOROUGH AT SECTION 680-57: “SCHEDULE XXIII” AND SECTION 680-58:  
“SCHEDULE XXIV” UNDER CHAPTER 680: “PARKING AND TRAFFIC” TO EXPAND  
METERED AND PERMIT PARKING ENFORCEMENT FROM 6:00PM TO 9:00PM

BE IT ORDAINED by the Governing Body of the Borough of Red Bank that the Borough’s Revised General Ordinances are hereby amended at Section 680-57: “Schedule XXIII” and Section 680-58: “Schedule XXIV” under Chapter 680: “Vehicles and Traffic” as follows (stricken text deleted; underlined text added):

§ 680-57 SCHEDULE XXIII: Parking Meter Zones

In accordance with the provisions of §§ 680-17 and 680-18 of this chapter, no person shall park between the hours specified in any of the following described locations unless they place the proper amount of money in the parking meter.

A. Parking lot meters.

§ 680-58 SCHEDULE XXIV: Permit Parking Zones

In accordance with the provisions of § 680-19 of this chapter, no person shall park between the

hours specified in the following described locations unless he/she has purchased a permit parking identification card for a specific lot that can only be used in that specific lot and that the parking identification card shall be prominently displayed on the rearview mirror or front dashboard of his vehicle in such a manner as to permit close examination by a parking enforcement officer. Metered parking shall be permitted in the following permit spaces after 2:00 p.m. on the days indicated.

**BE IT FURTHER ORDAINED** by the Governing Body of the Borough of Red Bank that any ordinances or portions thereof which are inconsistent with the provisions of this Ordinance are hereby repealed as of the effective date of this Ordinance. All other provisions of the Revised General Ordinances are ratified and remain in full force and effect.

**BE IT FURTHER ORDAINED** by the Governing Body of the Borough of Red Bank that if any provision of this Ordinance or the application of such provision to any person or circumstance is declared invalid, such invalidity shall not affect the other provisions or applications of this Ordinance which can be given effect, and to this end, the provisions of this Ordinance are declared to be severable.

**BE IT FURTHER ORDAINED** by the Governing Body of the Borough of Red Bank that

this Ordinance shall take effect immediately upon its passage and adoption according to law.
