**A RESOLUTION AUTHORIZING THE PURCHASE OF TWO (2) CINDER CUSTOM
CLASS A PUMPER ENGINES FOR THE RED BANK BOROUGH FIRE DEPARTMENT
UNDER A NATIONAL COOPERATIVE PURCHASE AGREEMENT THROUGH
FF1 APPARATUS & FIREFIGHTER ONE, LLC OF SPARTA, NJ**

WHEREAS the Borough of Red Bank is permitted to join national cooperative purchasing agreements under the authority of N.J.S.A. 52:34-6.2(b)(3); and

WHEREAS, FF1 Apparatus & Firefighter One, LLC, through its Houston Galveston Area Council National Cooperative Contract, meets the bidding and contract award process criteria established by the New Jersey Department of Community Affairs; and

WHEREAS, the Borough of Red Bank requires the purchase of two (2) Cinder Custom Class A Pumper Engines for the Red Bank Borough Fire Department at the Westside Hose Company and the Independent Fire Company; and

WHEREAS, it is the intent of the Red Bank Borough Purchasing Agent to make said purchase from FF1 Apparatus & Firefighter One, LLC, through its Houston Galveston Area Council National Cooperative Contract, pursuant to the proposal submitted to the Borough of Red Bank dated September 15, 2020 and attached hereto as Exhibit A; and

WHEREAS, the Red Bank Borough Fire Department has reviewed the proposal and has determined that said purchase through FF1 Apparatus & Firefighter One, LLC, by way of its Houston Galveston Area Council National Cooperative Contract will result in significant savings and be most beneficial to the Borough; and

WHEREAS, funds in the amount of \$1,000,000.00 are currently available for this purpose as certified by the Chief Financial Officer in account no(s). M-19-00-101-503.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the Borough of Red Bank that the Purchasing Agent is hereby authorized to authorize the purchase of two (2) Cinder Custom Class A Pumper Engines for the Red Bank Borough Fire Department at the Westside Hose Company and the Independent Fire Company from FF1 Apparatus & Firefighter One, LLC, through its Houston Galveston Area Council National Cooperative Contract, in the amount of \$1,000,000.00 as set forth in the proposal dated September 15, 2020 and attached hereto as Exhibit A; and

BE IT FURTHER RESOLVED that, to the extent applicable, this resolution is further contingent upon the Chief Financial Officer's Certification of Sufficient Funds.

BE IT FURTHER RESOLVED that the Clerk forward a certified true copy of this resolution to the Chief Financial Officer.
