**RESOLUTION OF THE BOROUGH OF RED BANK, COUNTY OF
MONMOUTH, STATE OF NEW JERSEY, RECOGNIZING RED BANK
PATROLMEN CEVIN ALBERT AND MILTON GRAY AND SERGEANT
MATTHEW EHRENREICH WITH THE LIFE SAVING AWARD**

WHEREAS, Patrolman Cevin Albert and Milton Gray and Sergeant Matthew Ehrenreich are deeply deserving of being recognized with a Life Saving Award after saving the life of a Borough resident; and

WHEREAS, on November 2, 2020, the officers responded to a dispute on Shrewsbury Avenue; and

WHEREAS, during the dispute a juvenile broke a window, unintentionally causing a severe laceration to his arm; and

WHEREAS, observing the severity of the injury and the presence of arterial bleeding the officers quickly determined that bleeding control was required as a lifesaving measure; and

WHEREAS, the officers had received training on tourniquet application and bleeding control and were equipped with combat tourniquets and were able to successfully apply the tourniquet despite an uncooperative patient; and

WHEREAS, the quick thinking and prompt actions of the officers was later deemed necessary and appropriate as the patient had severed his brachial artery which would have caused a fatal loss of blood; and

WHEREAS, the Chief of Police of the Borough of Red Bank has recommended that Patrolmen Cevin Albert and Milton Gray and Sgt. Matthew Ehrenreich each receive a Life Saving Award in recognition of their exemplary service.

NOW, THEREFORE, BE IT RESOLVED, by the governing body of the Borough of Red Bank, County of Monmouth, State of New Jersey as follows:

1. That the Mayor and Council wish to commend Patrolmen Cevin Albert and Milton Gray and Sergeant Matthew Ehrenreich for their exemplary actions and bestow upon each officer the Life Saving Award.

2. That a certified copy of this resolution be forwarded to Patrolman Cevin Albert, Patrolman Milton Gray and Sergeant Matthew Ehrenreich.
