**RESOLUTION AWARDING A CONTRACT FOR SOLID WASTE, BULK REFUSE
AND RECYCLABLE MATERIALS COLLECTION & DISPOSAL SERVICES TO
DELISA DEMOLITION, INC. BEGINNING FEBRUARY 1, 2021**

WHEREAS, the Borough of Red Bank, County of Monmouth, State of New Jersey (the "Borough") advertised specifications and solicited bids for a Contract for Solid Waste, Bulk Refuse, and Recyclable Materials Collection & Disposal Services (the "Contract"); and

WHEREAS, the Contract was advertised by the Borough for a period up to five (5) years, the initial term to commence on February 1, 2021 and end on January 31, 2024, with the option to renew for two, one-year increments, totaling five (5) years of services; and

WHEREAS, in accordance with the advertised specifications, two (2) bids were received for performance of the Contract as follows:

WHEREAS, the Borough Attorney has reviewed the bids submitted and found same to be legally acceptable and compliant; and

WHEREAS, pursuant to the advertised bid specifications, at the sole discretion and decision of the Borough, the Contract shall consist of the following: (1) either Option #1 or #2 or #3; and (2) either Option #4A or #4B; and (3) Option #5; and

WHEREAS, in accordance with the advertised specifications, the Borough has determined that the Contract shall consist of: (1) Option #2; (2) Option #4A; and (3) Option #5; and

WHEREAS, pursuant to the advertised bid specifications, the Contact shall be awarded to the lowest responsible bidder for the Contract in the aggregate;

NOW THEREFORE, BE IT RESOLVED, that the Mayor & Council of the Borough of Red Bank hereby award the advertised Contract and authorize the Borough to enter into the Contract with the lowest responsible bidder therefor, Delisa Demolition, Inc.; and

BE IT FURTHER RESOLVED, that this Resolution and the award of the Contract shall be advertised in accordance with the New Jersey Local Public Contracts Law; and

BE IT FURTHER RESOLVED, that a certified copy of this Resolution be forwarded to the Borough Administrator, Borough DPU Director, Borough CFO, Borough Attorney, Delisa Demolition, Inc., and Republic Services of NJ, LLC.
