A RESOLUTION AUTHORIZING THE PURCHASE OF FIELDTURF REVOLUTION 360 (ITEM# FTRV360-57)  
FOR COUNT BASIE FIELDS FROM THE EDUCATIONAL SERVICES COMMISSION OF NEW JERSEY, A  
NEW JERSEY STATE PURCHASING COOPERATIVE, THROUGH FIELDTURF USA, INC./TARKETT SPORTS  
CANADA, INC.

**WHEREAS**, pursuant to the New Jersey Local Public Contracts Law, the Borough of Red Bank, County of Monmouth, State of New Jersey (the “Borough”) is permitted to make purchases from New Jersey State Purchasing Cooperative Contracts without a duplicate bid process; and

**WHEREAS**, FieldTurf USA, Inc./Tarkett Sports Canada, Inc., through Educational Services Commission of New Jersey Cooperative Contract# ESCNJ 18/19-55, meets the bidding and award criteria established by the New Jersey Department of Community Affairs; and

**WHEREAS**, the Borough of Red Bank requires the purchase of a synthetic turf field and accompanying equipment for Count Basie Fields; and

**WHEREAS**, it is the intent of the Red Bank Borough Purchasing Agent to make said purchase from FieldTurf USA, Inc./Tarkett Sports Canada, Inc., through Educational Services Commission of New Jersey Cooperative Contract# ESCNJ 18/19-55, pursuant to its Pricing Proposal, dated May 20, 2021, and attached hereto as Exhibit A; and

**WHEREAS**, the Borough has reviewed the Proposal and has determined that accepting the Base Bid in the amount of \$438,438.00, together with Alternate No. 4 in the amount of \$33,199.00, from FieldTurf USA, Inc./Tarkett Sports Canada, Inc., through Educational Services Commission of New Jersey Cooperative Contract# ESCNJ 18/19-55, will result in significant savings and be most beneficial to the Borough; and

**WHEREAS**, funds in the amount of \$471,637.00 are currently available for this purpose as certified by the Chief Financial Officer;

**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and Council of the Borough of Red Bank that the Purchasing Agent is hereby authorized to accept the Base Bid in the amount of \$438,438.00, together with Alternate No. 4 in the amount of \$33,199.00, from FieldTurf USA, Inc./Tarkett Sports Canada, Inc., through Educational Services Commission of New Jersey Cooperative Contract# ESCNJ 18/19-55, for the purchase of a synthetic turf field and accompanying equipment for Count Basie Fields, in the total amount of \$471,637.00 as set forth in the Proposal dated May 20, 2021 and attached hereto as Exhibit A; and

**BE IT FURTHER RESOLVED** that account to be charged is C-04-21-001-201 and C-04-21-001-202 in an amount not to exceed \$471,637.00 and the Chief Financial Officer has issued a Certificate of Available Funds which is incorporated herein by reference

**BE IT FURTHER RESOLVED** that the Clerk forward a certified true copy of this resolution to the Chief Financial Officer.
