

ORDINANCE NO. 2021-14

ORDINANCE OF THE BOROUGH OF RED BANK, COUNTY OF MONMOUTH,
STATE OF NEW JERSEY AMENDING THE REVISED GENERAL ORDINANCES
OF THE BOROUGH AT SCHEDULE A: "TOWING & STORAGE FEE SCHEDULE"
ATTENDANT TO SECTION 652-9(J)(2): "MAXIMUM RATES" UNDER CHAPTER 652:
"TOWING" TO INCREASE SAID MAXIMUM TOWING RATES WITHIN THE BOROUGH

BE IT ORDAINED by the Governing Body of the Borough of Red Bank that the Borough's Revised General Ordinances are hereby amended at Schedule A: "Towing & Storage Fee Schedule" attendant to Section 652-9(J)(2): "Maximum Rates" under Chapter 652: "Towing" as follows (stricken text deleted; underlined text added):

SCHEDULE A

Towing and Storage Fee Schedule

All Autos and
Trucks to 3 Tons

a. Regular towing service

1. Borough day	\$85 <u>\$125</u>
2. Night, weekend and holiday	\$95 <u>\$125</u>
3. Flatbed (to be used only when necessary or requested by the police)	\$105 <u>\$125</u>
4. Towing elsewhere	As agreed in writing with owner prior to tow

When towing services are required, the day rate shall apply when the towing service is called by the police between 8:30 a.m. and 4:30 p.m., Monday through Friday, except scheduled national holidays. The night, weekend and holiday rates shall otherwise apply.

b. Storage service (must be inside or secured outside yard)

1. Each day	<u>\$30</u>
_____ (a) Inside building	\$30
_____ (b) Outside secured	\$25
_____ (c) Outside unsecured	\$20

c. Special services

_____ 1. If owner of vehicle appears on scene prior to tow truck arriving on scene but in time so that the police officer may cancel the request for towing, which cancellation shall be within five minutes of the original call to the towing operator	\$25
21. If owner of vehicle appears on scene after tow truck has arrived on scene but before the vehicle has been hooked up for tow	<u>\$30</u> <u>\$40</u>
32. If owner of vehicle appears on scene	<u>\$35</u> <u>\$50</u>

after tow truck has arrived on scene and after the vehicle has been hooked up for tow

43. If a vehicle has to be placed on dollies to secure transportation, or if go-jacks are used to secure the vehicle, then an additional fee of \$25

54. To move a motor vehicle by use of a cable and winch from a position that is not accessible for direct hookup by conventional means or loading onto a tow truck. (Winching is not pulling a motor vehicle onto a tilt bed or car carrier, nor lifting a motor vehicle with a conventional tow sling.) \$90-\$100 for the first ½ hour; \$40-\$50 for each ½ hour, or part thereof, thereafter

BE IT FURTHER ORDAINED by the Governing Body of the Borough of Red Bank that any ordinances or portions thereof which are inconsistent with the provisions of this Ordinance are hereby repealed as of the effective date of this Ordinance. All other provisions of the Revised General Ordinances are ratified and remain in full force and effect.

BE IT FURTHER ORDAINED by the Governing Body of the Borough of Red Bank that if any provision of this Ordinance or the application of such provision to any person or circumstance is declared invalid, such invalidity shall not affect the other provisions or applications of this Ordinance which can be given effect, and to this end, the provisions of this Ordinance are declared to be severable.

BE IT FURTHER ORDAINED by the Governing Body of the Borough of Red Bank that this Ordinance shall take effect immediately upon its passage and adoption according to law.
