**A RESOLUTION AUTHORIZING THE PURCHASE OF A 2021 FORD EXPLORER
(Parking Utility)**

WHEREAS, The Borough of Red Bank is permitted to join cooperative purchasing agreements under the authority of N.J.S.A. 5:34-7; and

WHEREAS, the Educational Services Commission of New Jersey (ESCNJ) bidding and contract award process meets the criteria as established by the Department of Community Affairs; and

WHEREAS, The Borough of Red Bank intends to participate in the Educational Services Commission of New Jersey (ESCNJ) contract award, specifically contract #ESCNJ 20/21-09, to purchase Vehicles; and

WHEREAS, It is the intent of the Red Bank Borough Purchasing Agent to make a purchase pursuant to said contract award to Beyer Ford pursuant to the proposal submitted to the Borough of Red Bank dated May 27, 2021; and

WHEREAS, the Director of the Department of Utilities has reviewed the proposal and has determined that said purchase through the Educational Services Commission of New Jersey (ESCNJ) contract award, contract #ESCNJ 20/21-09 will result in significant savings to the Borough, and

WHEREAS, funds in the amount of \$34,982.27 are currently available for this purpose as certified by the Chief Financial Officer in account no(s). M-17-00-101-801

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the Borough of Red Bank that the Purchasing Agent is hereby authorized to authorize the purchase of a 2021 Ford Explorer, through the Educational Services Commission of New Jersey (ESCNJ) contract #ESCNJ 20/21-09, from Beyer Ford, in the amount of \$34,982.27 as set forth in their proposal dated May 27, 2021.

BE IT FURTHER RESOLVED that, to the extent applicable, this resolution is further contingent upon the Chief Financial Officer's Certification of Sufficient Funds.

BE IT FURTHER RESOLVED that the Clerk forward a certified true copy of this resolution to the Chief Financial Officer.
