**A RESOLUTION AUTHORIZING AMENDMENT OF THE BOROUGH’S
PROFESSIONAL SERVICES CONTRACT WITH GENE J. ANTHONY, ESQ.
TO INCREASE THE AMOUNT NOT TO EXCEED FROM \$6,000 TO \$12,000
FOR RENT LEVELING BOARD ATTORNEY SERVICES**

WHEREAS, by Resolution No. 21-20, the Borough of Red Bank contracted with the Gene J. Anthony, Esq. as its Rent Leveling Board Attorney to perform legal services for the Borough at an hourly rate of \$150 with an amount not to exceed \$6,000 from January 1, 2021 through December 31, 2021; and

WHEREAS, the award of this contract was pursuant to a fair and open process in accordance with N.J.S.A. 19:44A-20-1, *et seq.*; and

WHEREAS, due to unforeseen circumstances requiring the performance of additional legal services for the Borough, Eugene J. Anthony, Esq. has exceeded the amount of its annual contract with the Borough to date; and

WHEREAS, the Borough requires the services of a Rent Leveling Board Attorney for the remainder of the calendar year, notwithstanding exhaustion of the budget line item;

NOW, THEREFORE, BE IT RESOLVED by Governing Body of the Borough of Red Bank, County of Monmouth, State of New Jersey, that the professional services contract entered into between Eugene J. Anthony, Esq. and the Borough is hereby amended to increase the amount not to exceed to \$12,000. This contract is awarded without competitive bidding as a “Professional Services Contract: in accordance with N.J.S.A. 40A:11-5 (1) (a) (1) of the Local Public Contracts Law. The Chief Financial Officer hereby certifies that the account number(s) to be charged is (are) 1-01-25-270-207 and 1-01-25-212-207 to the 2021 budget.

BE IT FURTHER RESOLVED that the Borough Clerk forward a certified true copy of this resolution to the Borough Administrator, Borough CFO, and Eugene J. Anthony, Esq.
