**A RESOLUTION ACCEPTING BIDS AND AWARDING CONTRACT  
FOR 2019/2020 NJDOT IMPROVEMENTS TO BROAD STREET**

**WHEREAS**, on July 28, 2021, bids were received for the Borough's planned 2019/2020 NJDOT Improvements to Broad Street, as follows:

**WHEREAS**, the Borough Engineer has reviewed the bids received from the aforementioned contractors; and

**WHEREAS**, the Borough Engineer has recommended award of the contract to the lowest responsible bidder, Montana Construction Corp., Inc. of Lodi, New Jersey, in the amount of \$2,686,769.00 for Base Bid Items 1 through 27, D-1 through D-9, SS-1 through SS-8, and M-1 through M-9, as available funding permits, subject to review by the Borough Attorney; and

**WHEREAS**, the Borough Attorney has reviewed the award and finds same to be legally acceptable and appropriate;

**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and Council of the Borough of Red Bank that the above-described bid received from Montana Construction Corp., Inc. of Lodi, New Jersey for the Borough's 2019/2020 NJDOT Improvements to Broad Street is accepted contingent on DEP approval and pursuant to the recommendation of the Borough Engineer and review by the Borough Attorney.

**BE IT FURTHER RESOLVED** that the Mayor and Clerk are authorized and requested to sign and deliver applicable contract(s) on behalf of the Borough of Red Bank, subject to review by the Borough Attorney, including review of bid bond and surety provided by the low bidder.

**BE IT FURTHER RESOLVED** that the bid and bid securities of the second and third lowest bidders, Earle Asphalt Company and Lima Charlie Construction, shall be retained and held open, pending execution of the awarded contract by Montana Construction Corp., Inc.

**BE IT FURTHER RESOLVED** that the Borough Clerk forward a certified true copy of this resolution to the Borough Administrator, Borough CFO, Borough Engineer, Montana Construction Corp., Inc., and to the unsuccessful bidders.
