



INSTRUCTIONS FOR VOTING ON THE VOTING MACHINE

- 1. Check in with the board worker via the poll pad.
- 2. Receive an authority-to-vote slip, as well as a ballot card.
- 3. Proceed to the voting machine. Hand your authority-to-vote slip to the board worker. Insert the ballot card, notch to the top right. The ballot will appear on the screen.
- 4. Make your selection by touching the screen. Tap “ACCEPT.”
- 5. Review your selection on the summary screen. To make changes, touch the contest and make a selection.
- 6. Touch “PRINT BALLOT” to review printed card in the window to the right, then touch “CAST BALLOT.” The card is then deposited into a secure card container for tabulation.
- 7. Visit MonmouthCountyVotes.com for more information and instructional videos.
- 8. Before entering the machine, if you have any questions about voting, ask the board worker.

**Pursuant to N.J.S.A. 40:45-13 within 10 days after the expiration of the time for filing certificates, statements and petitions for candidates, and the drawing for position, the municipal clerk shall cause the names of the candidates as they are to appear upon the ballots to be published in proper form once in each of the two newspapers having circulation in the municipality and published in this State.*

*** Pursuant to N.J.S.A. 40:45-12 there is no specific deadline in the statute for ballot draw, but the clerk must give at least a two day notice by certified mail to the candidates. N.J.S.A. 40:45-13 also provides that within 10 days after the petition deadline and the ballot draw, the municipal clerk is to publish once in each of two newspapers having circulation in the municipality and the state, the names of the candidates as they are to appear on the ballot.*
