## COUNCIL-MANAGER FORM OF GOVERNMENT IMPLEMENTATION UPDATE

In the November 2022 general election, Red Bank voters approved the Charter Study Commission's recommendation of a Council-Manager form of government under the Faulkner Act. Under the approved terms, Red Bank has a directly elected mayor and six councilmembers through at-large, nonpartisan elections with runoffs if necessary. The councilmembers have staggered terms, such that there is an election every two years for certain seats.

This new form of government, which took effect July 1, 2023, brings about certain changes in the powers of mayor, council, and the administrator/manager.

Under the former Borough form, the mayor only voted in the event of a tie, but had the power to nominate officers and certain employees and to veto ordinances. In the new Council-Manager form, the mayor is a full voting member of the council, but does not have any greater powers than the other councilmembers.

With respect to the council, in the Borough form, it served as both the executive and legislative authority, subject to potential delegation of executive powers to an administrator by ordinance. In contrast, the Council-Manager form limits the council to legislative functions, and it establishes a manager

that carries out the executive functions of Red Bank. While the council previously hired and fired all employees, the manager now has that prerogative, except for the manager position itself, the Borough Clerk, and the Tax Assessor.

The Council-Manager form establishes a "strong" manager to be chosen based upon qualifications and experience. In turn, the manager is subject to removal by the council under a simple majority vote, rather than a 2/3 supermajority in the former Borough form.

At the September 28, 2023 Borough Council meeting, the governing body introduced an ordinance to implement the Faulkner Act. The ordinance repeals all code provisions that are specific to the Borough form of government, replacing them with new terms establishing the Council-Manager form.

Among other things, these revisions address the organization of the municipal government, the duties of officers, departments, and agencies, and election procedures. Once receiving final adoption, residents will be able to refer to the Borough Code to better understand Red Bank's new form of government.

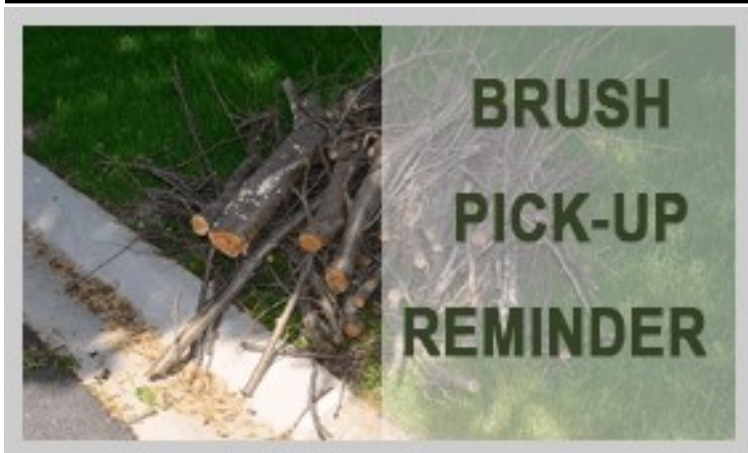

This month, the National Planning Association (APA) encourages everyone to celebrate the role that planning plays in creating great communities each October with National Community Planning Month. The goal of planning is to maximize residents' health, safety, and economic well-being in ways that reflect the unique needs, desires, and culture of those who live and work within the community. One of the ways local municipalities enhance the goals of planning is by having a Planning and Zoning Department.

The Borough of Red Bank Planning and Zoning Department is responsible for several aspects of community planning, including historic preservation, development regulations, and affordable housing. The Department works with residents, governing officials, local organizations, business owners, attorneys, architects, engineers, and other community stakeholders. It administers the land use ordinance of the Borough.

The ordinance's purpose is to establish a pattern of the regulation of the uses of land, buildings, and structures based on the land use element



of the Master Plan and Municipal Land Use Law (N.J.S.A 40-55D). Additionally, this Department works closely with others throughout the Borough, such as Code Enforcement, the Fire Marshall's Office, the Construction Department, and the Borough Engineer. Finally, the oversight of the Planning Board and the Zoning Board of Adjustment is done through the Planning and Zoning Department.
