**A RESOLUTION AUTHORIZING PURCHASE OF POLICE VEHICLES UNDER A NEW JERSEY COOPERATIVE PURCHASE AGREEMENT**

**WHEREAS**, The Borough of Red Bank is permitted to join New Jersey cooperative purchasing agreements under the authority of N.J.S.A. 40A:11-12; and

**WHEREAS**, the Cranford Police Cooperative Pricing System (ID# 47CPCPS) bidding and contract award process meets the criteria as established by the Department of Community Affairs; and

**WHEREAS**, The Borough of Red Bank intends to participate in the Cranford Police Cooperative Pricing System (ID) contract award, specifically contract # 47CPCPS, to purchase two (2) police vehicles; and

**WHEREAS**, it is the intent of the Red Bank Borough Purchasing Agent to make a purchase pursuant to said contract award to Gentilini Motors pursuant to the proposal submitted to the Borough of Red Bank; and

**WHEREAS**, the Chief of Police has reviewed the proposal and has determined that said purchase through the Cranford Police Cooperative Pricing System contract award, contract # 47CPCPS will result in significant savings to the Borough, and

**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and Council of the Borough of Red Bank that the Purchasing Agent is hereby authorizes the purchase of two (2) 2022 Chevrolet Tahoe 9CI Patrol Spec, through the Cranford Police Cooperative Pricing System, contract #47CPCPS, from Gentilini Motors, in the amount of \$81,684.48 as set forth in their quote #EST5889 dated 3/23/2022.

**BE IT FURTHER RESOLVED**, the account to be charged is M-19-00-101-101 in an amount not to exceed \$90,000 and that the Chief Financial Officer has issued a Certificate of Available Funds which is incorporated herein by reference.

**BE IT FURTHER RESOLVED** that the Clerk forward a certified true copy of this resolution to the Chief Financial Officer.
