**A RESOLUTION AWARDING A CONTRACT FOR THE EMERGENCY ABATEMENT
OF ASBESTOS FROM THE GRAND STANDS AT COUNT BASIE PARK UNDER THE
EDUCATIONAL SERVICES COMMISSION OF NEW JERSEY COOPERATIVE
PURCHASE AGREEMENT.**

WHEREAS, the Director of the Department of Public Utilities was notified of the potential presence of asbestos under the grand stands at Count Basie Park; and

WHEREAS, All Risk, Inc, and its partners TTI Environmental, Inc, and Pernaco Inc. were dispatched to the site to determine the existence of asbestos at this facility and provide a proposal for its proper abatement pursuant to NJAC 5:23-8; and

WHEREAS, the presence of asbestos was confirmed and its removal is emergent; and

WHEREAS, The Borough of Red Bank is permitted to join cooperative purchasing agreements under the authority of N.J.S.A. 5:34-7; and

WHEREAS, the Educational Services Commission of New Jersey (ESCNJ) bidding and contract award process meets the criteria as established by the Department of Community Affairs; and

WHEREAS, The Borough of Red Bank intends to participate in the Educational Services Commission of New Jersey (ESCNJ) contract award, specifically contract #ESCNJ 17/18-34, for disaster recovery; and

WHEREAS, It is the intent of the Red Bank Borough Purchasing Agent to make a purchase pursuant to said contract award to All Risk, Inc pursuant to the proposal submitted to the Borough of Red Bank dated February 25, 2022; and

WHEREAS, funds in the amount of \$146,096.00 are currently available for this purpose as certified by the Chief Financial Officer in account no. T-21-56-850-801

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the Borough of Red Bank that the Purchasing Agent is hereby authorized to authorize the award of disaster recovery services, through the Educational Services Commission of New Jersey (ESCNJ) contract #ESCNJ 17/18-34, from All Risk inc., in the amount of \$146,096.00 as set forth in their proposal dated February 25, 2022.

BE IT FURTHER RESOLVED that, to the extent applicable, this resolution is further contingent upon the Chief Financial Officer's Certification of Sufficient Funds.

BE IT FURTHER RESOLVED that the Borough Clerk forward a certified true copy of this resolution to the Borough Administrator, Borough CFO, and DPU Director.
