RESOLUTION AWARDING PROFESSIONAL SERVICES CONTRACT FOR THE
PROFESSIONAL ENGINEERING AND CONSTRUCTION MANAGERMENTS SERVICES FOR
THE 2020 MONMOUTH COUNTY INFRASTRUCTURE GRANT – DPW HVAC
INSTALLATION

WHEREAS, the Borough Governing Body has identified a need for the installation of a HVAC system located in the public works building; and,

WHEREAS, the Borough of Red Bank was awarded a 2020 Monmouth County Infrastructure Grant for the same; and

WHEREAS, based on the size and scope of such undertaking, the professional services of the Borough Engineer are considered desirable by Borough management; and,

WHEREAS, the Mayor and Council (hereinafter, the “Governing Body” of the Borough concur with the sentiments and recommendation of the Borough management and wish to enlist the professional services of the Borough Engineer for the necessary services associated with the project here forward known as “2020 Monmouth County Infrastructure Grant – DPW HVAC Installation”.

NOW THEREFORE BE IT RESOLVED, by the Mayor and Council of the Borough of Red Bank, County of Monmouth, State of New Jersey, that a Professional Services Contract for the professional engineering and construction managements services for the project: “2020 Monmouth County Infrastructure Grant – DPW HVAC Installation.” be awarded to Harbor Consultants 320 N Ave E, Cranford, NJ 07016 for the sum not to exceed Six Thousand Five Hundred and Zero Cents (\$6,500); and,

BE IT FURTHER RESOLVED that this Resolution shall take effect upon certification on this Resolution by the Borough Chief Financial Officer that sufficient funds are available for stated purpose; and,

BE IT FURTHER RESOLVED that charges incrementally incurred and paid associated with this contract shall be pursuant to the contract terms authorized in Resolution #22-02 of January 1, 2022.
