

**ORDINANCE OF THE BOROUGH OF RED BANK, COUNTY OF MONMOUTH, NEW JERSEY  
AMENDING AND SUPPLEMENTING CHAPTER 680, "VEHICLES AND TRAFFIC," SECTION  
680-57, "SCHEDULE XXIII: "PARKING METER ZONES"**

**BE IT ORDAINED** by the Governing Body of the Borough of Red Bank that Chapter 680 of the Revised General Ordinances of the Borough of Red Bank, Monmouth County, "Vehicles and Traffic," Section 680-57 Schedule XXIII: Parking Meter Zones is hereby amended and supplemented as follows:

**SECTION ONE:** Schedule XXIII: Parking Meter Zones is amended and supplemented as follows: (*strikeouts denote deletions, underlined text denotes additions*):

## SCHEDULE XXIII: Parking Meter Zones

In accordance with the provisions of Subsection 680-17 and 680-18 of Chapter 680, no person shall park between the hours specified in any of the following described areas unless they place the proper amount of money in the parking meter.

## B. Street Meters

Monmouth Street	4 Hours	9:00 am to 9:00 pm; Monday through Saturday	Both sides from Broad Street westerly to Bridge Avenue for the entire length	\$1.50/hour \$0.50/15 minutes
<u>Oakland Street</u>	<u>4 Hours</u>	<u>9:00 am to 9:00 pm; Monday through Saturday</u>	<u>South side from Bridge Avenue to the train tracks</u>	<u>\$1.50/hour</u> <u>\$0.50/15 minutes</u>

**SECTION TWO:** Any ordinances or portions thereof which are inconsistent with the provisions of this Ordinance are hereby repealed as of the effective date of this Ordinance.

**SECTION THREE:** If any provision of this Ordinance or the application of such provision to any person or circumstance is declared invalid, such invalidity shall not affect the other provisions or applications of this Ordinance which can be given effect, and to this end, the provisions of this Ordinance are declared to be severable.

**SECTION FOUR:** This Ordinance shall take effect immediately upon its passage and adoption according to law.
