**RESOLUTION NO. NP23-09**

**AUTHORIZE SHARED SERVICE AGREEMENT BETWEEN THE COUNTY OF MONMOUTH AND THE  
BOROUGH OF RED BANK FOR EMERGENCY DISPATCH SERVICES**

**WHEREAS**, the New Jersey Uniform Shared Services and Consolidation Act (C.40A:65-1, et seq.) authorizes local units such as the Borough of Red Bank to enter into shared service agreements with other local units; and

**WHEREAS**, the Monmouth County Sheriff's Office entered into a Communications Shared Services agreement with the Borough of Red Bank in 2014 whereas the County would provide computer related services to 9-11 dispatching functions for the Municipality as required; and

**WHEREAS**, it is in the best interest of the Borough of Red Bank to renew the agreement with the Monmouth County Sheriff's Office for a three-year term from January 1, 2023 through December 31, 2025 with an annual fee of \$15,262.00 for the first year and with the second and third years being subject to a 2 percent increase each year;

**NOW, THEREFORE, BE IT RESOLVED** by the Governing Body of the Borough of Red Bank that the Mayor and Municipal Clerk be and they are hereby authorized to execute the attached Shared Services Agreement for the Provision of Emergency 9/11 Dispatch Services with the Monmouth County Sheriff's Office.

**BE IT FURTHER RESOLVED** that the Municipal Clerk forward a certified copy of this resolution, along with the executed Shared Services Agreement for the Provision of Emergency 9/11 Dispatch Services to the Business Administrator of the Monmouth County Sheriff's Office, 2500 Kozloski Road, Freehold, New Jersey 07728 and the Clerk of the Board of Chosen Freeholders, County of Monmouth, Hall of Records, 1 E. Main Street, Freehold, New Jersey 07728.

**BE IT FURTHER RESOLVED** that the Agreement shall be subject to review and approval by the Borough Attorney.
