

2. Any contract amendments which may become necessary shall be subject to the borough's ability to appropriate sufficient funds, the sole discretion of the Borough Council.
3. The Council hereby authorizes the Mayor, and or the Manager to execute any and all documents and take any and all actions necessary to complete and realize the intent and purpose of the resolution.
4. The Borough is in receipt of the Stockholder Disclosure Form, Contribution Disclosure Form, Certificate of Employee Information Report, Business Registration Certificate, and Certificate of Insurance.
5. The Mayor or Manager is hereby authorized to execute an agreement as outlined herein with: Vulcan Construction Group, Inc.
