RESOLUTION NO. 23-88

**AWARDING CONTRACT FOR REHABILITATION HOUSING SERVICES FOR 107
MCLAREN STREET TO PROWN'S WINDOWS AND DOORS IN ORDER TO ADVANCE
THE BOROUGH'S AFFORDABLE HOUSING REHABILITATION PLAN**

WHEREAS, the Borough of Red Bank, County of Monmouth, State of New Jersey (the "Borough") has a need to retain the services of a qualified contractor for housing rehabilitation for 107 McLaren Street to advance the Borough's Affordable Housing Rehabilitation Plan; and

WHEREAS, the Municipal Housing Liaison solicited quotes from four (4) contractors to perform the rehabilitation and scope of work for 107 McLaren Street as follows:

- 1) Prown's Windows and Doors \$10,570.00
- 2) J.R Ramirez Construction \$11,459.00
- 3) Ace Handyman Services \$12,288.00
- 4) Steli Property Management \$10,353.00; and

WHEREAS, because the value of the services will not exceed the bid threshold of \$17,500, pursuant to the Local Public Contracts Law, N.J.S.A. 40A:11-6.1, the Borough is permitted to award a contract to the contractor "whose response is most advantageous, price and other factors considered"; and

WHEREAS, Prown's Windows and Doors was selected by the property owner; and

WHEREAS, after reviewing the quotes, in light of price and other factors considered, the Municipal Housing Liaison recommends awarding a contract for the affordable housing rehabilitation of 107 McLaren Street to Prown's Windows and Doors; and

WHEREAS, the property owner has agreed to be responsible for paying \$70.00 of the total contract amount; and

WHEREAS, the Borough of Red Bank will pay \$10,500.00 of the total contract amount; and

WHEREAS, the Borough CFO has certified that funds are available to the contract in account #T-18-09-800-000;

NOW THEREFORE, BE IT RESOLVED that the Governing Body of the Borough of Red Bank hereby awards a contract in the amount of \$10,570.00 to Prown's Windows and Doors for the affordable housing rehabilitation of 107 McLaren Street; and

BE IT FURTHER RESOLVED that a certified copy of this resolution be sent to the Chief Financial Officer, Municipal Housing Liaison, Red Bank Affordable Housing Corporation, and Prown's Window and Doors.
