RESOLUTION NO. 23-174

**AWARDING A CONTRACT TO MARK WOSZCZAK MECHANICAL CONTRACTORS
INC.IN THE AMOUNT OF \$528,165.60 FOR INSTALLATION AND REPAIR OF WATER AND
SEWER MAINS**

WHEREAS, the Borough of Red Bank (the “Local Unit”), requires a qualified contractor for the Installation and Repair of Water and Sewer Mains; and

WHEREAS, the borough invited bidders for said services and received two (2) bid as follows on June 21, 2023; and

1) Mark Woszczak Mechanical Contractors Inc.	Manasquan, NJ	\$528,165.60
2) Montana Construction Corp. Inc.	Lodi, NJ	\$1,155,295.20

WHEREAS, CME Associates reviewed and tabulated the bids including bidder qualifications and provided the recommendation of award to Mark Woszczak Mechanical Contractors Inc. in the amount of \$528,165.60

WHEREAS, the engineer and borough administrator recommend awarding a contractor to Mark Woszczak Mechanical Contractors Inc., the lowest responsible bidder, for the Installation and Repair of Water and Sewer Mains in the amount of \$\$528,165.60, subject to approval of the New Jersey Department of Environmental Protection, pursuant to for a term to expire upon completion of the project in accordance with NJSA 40A:11-15(9);; and

NOW, THEREFORE, BE IT RESOLVED by the mayor and Council of the Borough of Red Bank that a contract is awarded to Mark Woszczak Mechanical Contractors Inc. in the amount of \$528,165.60 subject to the approval of the New Jersey Department of Environmental Protection for a term to expire upon completion of the project: subject to the following:

1. The award of this contract is subject to finalization of the contract terms to be drafted and approved by Borough Counsel.
2. Any contract amendments which may become necessary shall be subject to the borough’s ability to appropriate sufficient funds, the sole discretion of the Borough Council.
3. The Council hereby authorizes the mayor, and or the administrator to execute any and all documents and take any and all actions necessary to complete and realize the intent and purpose of the resolution.
4. The Borough is in receipt of the Stockholder Disclosure Form, Contribution Disclosure Form, Certificate of Employee Information Report, Business Registration Certificate, and Certificate of Insurance.
5. The Mayor or Administrator is hereby authorized to execute an agreement as outlined herein with: Mark Woszczak Mechanical Contractors Inc.
