AWARDING A CONTRACT FOR EMERGENCY REPAIRS TO DPW GARAGE

WHEREAS, the Borough of Red Bank (the “Local Unit”), requires a qualified contractor for Emergency Repairs to the DPW Garage; and

WHEREAS, the borough invited bidders for said services and on Nov. 7, 2023 received 3 bids, summarized as follows; and

WHEREAS, T and M Associates reviewed and tabulated the bids including bidder qualifications and provided the recommendation of award to K&D Contractors, LLC in the amount of \$ 87,136.50; and

NOW, THEREFORE, BE IT RESOLVED by the mayor and Council of the Borough of Red Bank that a contract is awarded to K&D Contractors, LLC in the amount of \$ 87,136.50 subject to the following:

1. The award of this contract is subject to finalization of the contract terms to be drafted and approved by Borough Counsel.
2. Any contract amendments which may become necessary shall be subject to the borough’s ability to appropriate sufficient funds, the sole discretion of the Borough Council.
3. The Council hereby authorizes the mayor, and or the manager to execute any and all documents and take any and all actions necessary to complete and realize the intent and purpose of the resolution.
4. The Borough is in receipt of the Stockholder Disclosure Form, Contribution Disclosure Form, Certificate of Employee Information Report, Business Registration Certificate, and Certificate of Insurance.
