**AUTHORIZING CLOSEOUT CHANGE ORDER RELATED TO THE CONTRACT WITH K&D CONTRACTORS  
FOR THE EMERGENCY REPAIRS TO THE DPW MECHANIC GARAGE PROJECT**

**WHEREAS**, the Borough previously entered into a contract with **K&D Contractors**, for the **Emergency Repairs to the DPW Mechanic Garage** project: and

**WHEREAS**, the Borough Engineer has recommended approval of Closeout Change Order #1, dated November 29, 2023, and Change Order #2, dated December 4, 2023, to the project. The Closeout Change Orders resulted in an increase of \$936.50 in the overall project cost from the original contract amount of \$87,136.50 to the final adjusted amount of \$88,073.00;

**BE IT RESOLVED**, by the Mayor and Council of the Borough of Red Bank of Monmouth County, New Jersey upon recommendation of the Borough Engineer that Closeout Payment for the contract be and is hereby approved; and

**BE IT RESOLVED** that the payment authorized herein is conditioned upon compliance with the requirements of N.J.S.A. 10:5-31 et seq. and N.J.A.C. 17:27 et. seq.; and


