**RESOLUTION NO. 24-85**

**AWARDING A FAIR AND OPEN PROFESSIONAL SERVICES CONTRACT FOR ASSET  
MAPPING SERVICES**

**WHEREAS**, the Borough Manager of Red Bank solicited proposal to furnish and deliver professional services to the Borough, specifically Borough Asset Mapping Services; and

**WHEREAS**, on the recommendation of the Borough Manager, VIALYTICS AMERICAS INC of Kinnelon, New Jersey appears best qualified to provide the services of the type and nature requested; and


**WHEREAS**, the Local Public Contracts Law (N.J.S.A. 40:11-1 et seq.) requires that the resolution authorize the award of the contract for "Professional Services" without competitive bids and the contract itself must be available for public inspection;

**NOW, THEREFORE, BE IT RESOLVED**, by the Governing Body of the Borough of Red Bank, County of Monmouth, State of New Jersey, that:

1. The Borough Manager is hereby authorized and directed to enter into a professional services contract with **VIALYTICS AMERICAS INC, 1483 State Route 24 Suite 4, Kinnelon, NJ 07405** to perform Asset Mapping Services Professional Services as set forth in VIALYTICS AMERICAS INC's, with a contract term of (36) thirty-six months.
2. The engagement of VIALYTICS AMERICAS INC is exempt from public bidding as a professional service under N.J.S.A. 40A:11-5.1(a)(i), and is being awarded under a "fair and open" process in accordance with New Jersey Pay-to-Play law.
3. Notice of the Resolution shall be published in the designated official newspapers as required by law within ten (10) days of the passage of this Resolution.
4. That the account(s) to be charged are:
  - a. 4-01-20-100-239 (Admin) \$10,218.26
  - b. 4-05-55-502-239 (WS) \$3,266.62
  - c. 4-09-55-502-239 (Parking) \$943.62

in an amount not to exceed \$ 14,428.50 and that the Chief Financial Officer has issued a Certificate of Available Funds which is incorporated herein by reference

5. A certified copy of this resolution be forwarded to the Borough Manager, Chief Financial Officer and VIALYTICS AMERICAS INC.
