RESOLUTION NO. 24-18

**ACCEPTING THE PERFORMANCE GUARANTEE POSTED BY ONE GLOBE COURT, LLC
FOR THE DEVELOPMENT PROJECT LOCATED AT BLOCK 28, LOT 4**

WHEREAS, pursuant to the Planning and Development Regulations of the Borough of Red Bank (the "Borough"), One Globe Court, LLC is required to post \$168,998.40 in the form of an acceptable bond or letter of credit, together with a cash deposit of \$18,777.60, for a total performance guarantee in the amount of \$187,776.00 in connection with a development project located upon the properties known as Block 28, Lot 4, which guarantee must be posted before starting construction of the improvements; and


WHEREAS, the Governing Body of the Borough has been advised by the Planning and Zoning Department that a performance bond in the amount of \$168,998.40 has been issued by United States Surety Company, 225 Schilling Circle, Suite 265, Hunt Valley, Maryland 21031 for Block 28 Lot 4; and

WHEREAS, the Governing Body has been advised by the Borough Planning and Zoning Department that One Globe Court, LLC posted a cash deposit in the amount of \$18,877.60; and

WHEREAS, the acceptance of this performance guarantee is permitted and in accordance with the provisions of the New Jersey Municipal Land Use Law and the Borough's Planning and Development Regulations:

NOW, THEREFORE, BE IT RESOLVED, by the Governing Body of the Borough of Red Bank, County of Monmouth, State of New Jersey as follows:

1. That the Governing Body does hereby accept the performance bond in the amount of \$168,998.40 has been issued by United States Surety Company, 225 Schilling Circle, Suite 265, Hunt Valley, Maryland 21031 and the cash deposit in the amount of \$18,877.60 from One Globe Court, LLC for Block 28, Lot 4; and
2. That a certified copy of this resolution be forwarded to the Chief Financial Officer, the Borough Planning and Zoning Department, and One Globe Court, LLC.
