RESOLUTION NO. 24-20

AUTHORIZING CHANGE ORDER NO. 3 RELATED TO THE CONTRACT WITH MONTANA CONST., INC. FOR THE LEAD SERVICE TEST PIT AND REPLACEMENT PROJECT

WHEREAS, the Borough previously entered into a contract with **MONTANA CONSTRUCTION**, for the **Lead Service Test Pit and Replacement** project: and

WHEREAS, the Borough Engineer has recommended approval of Change Order No. 3, dated December 18, 2023 to the aforementioned Project, in order to address actual field quantities needed for completion of the project; and

WHEREAS, items #10 and #11 were eliminated (reduction \$18,500) and items #9, #22, and #A2 were increased (additional \$480,000); these contract changes yield a total net cost not to exceed \$461,500.00;

<u>REDUCTIONS:</u>
Item 10 HMA Milling, 3" or LESS has been eliminated from the contract
Item 11 HMA 9.5M64 Surface Course has been eliminated from the contract
<u>EXTRA:</u>
Item 9 - Curb Stop Box (if and where directed) has been increased by 30 units based on the current as built field conditions
Item 22 Allowance has been increased by \$12,500 to anticipate unforeseen leaking services
Item A2 - Water Service Replacement (Partial Length) is being increased by 100 units based on previous test pit results


NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the Borough of Red Bank that Change Order No. 3 to the **Lead Service Test Pit and Replacement** Project, dated December 18, 2023 is hereby approved with a supplementary price increase not to exceed \$461,500.00: and

BE IT FURTHER RESOLVED that the Chief Financial Officer has certified that the funds are current available in account No. C 04-21-001-103; and

BE IT FURTHER RESOLVED, to the extent applicable, this resolution is further contingent upon the expiration of the twenty-day estoppel period for any and all bonded funds for this project.
