AUTHORIZING PROFESSIONAL ENVIRONMENTAL SERVICES FOR SUNSET AVENUE

WHEREAS, the Borough Governing Body has identified a need for Professional Environmental Services at the former Red Bank Incinerator (aka Red Bank Landfill and Sunset Landfill) located at Sunset Avenue in the Borough of Red Bank; and

WHEREAS, the Mayor and Council (hereinafter, the "Governing Body" of the Borough concur with the sentiments and recommendation of the Borough management and wish to enlist the professional services Vanasse Hangen Brustlin, Inc. (VHB) for Professional Environmental Services at the former Red Bank Incinerator (aka Red Bank Landfill and Sunset Landfill) located at Sunset Avenue in the Borough of Red Bank, Monmouth County, New Jersey (herein referred to as the Site), Block 84, Lot 64 which encompasses 8.55 acres, the project here forward known as for the Sunset Avenue Project (6/19/2024 Project No. 21748.01);

NOW THEREFORE BE IT RESOLVED, by the Mayor and Council of the Borough of Red Bank, County of Monmouth, State of New Jersey, that a Professional Services Contract for Professional Environmental Services for the Sunset Avenue Project; to Vanasse Hangen Brustlin, Inc. for the sum not to exceed twelve thousand dollars (\$12,000.00); and,

Scope of Services:

Vanasse Hangen Brustlin, Inc. (VHB) is pleased to provide the Borough of Red Bank (herein referred to as the Client) this Scope of Services (SOS) for Professional Environmental Services at the former Red Bank Incinerator (aka Red Bank Landfill and Sunset Landfill) located at Sunset Avenue in the Borough of Red Bank, Monmouth County, New Jersey (herein referred to as the Site). The Borough of Red Bank further identifies the Site as Block 84, Lot 64 which encompasses 8.55 acres.

Specifically, this SOS includes tasks required to complete the initial stages of an application for an Environmental and Climate Justice Community Change Grant funded by the United States Environmental Protection Agency (USEPA). This grant provides an opportunity for the transformation of disadvantaged communities into healthy, climate resilient, and thriving communities by providing funding to overcome longstanding environmental challenges and implement meaningful solutions to meet community needs both now and for generations to come. Applications are accepted on a rolling basis through November 21, 2024. A Track I application will be submitted for the former Red Bank Incinerator Site, and awards under Track I are expected to be between \$10-\$20 million each. The initial stages of the application include a virtual meeting with USEPA for an oral presentation, after which the USEPA will review the application and decide whether or not the applicant is to proceed based on scoring.

VHB's Cost Estimate to assist with the grant application is as follows:

- Task 1: Preliminary Meeting with USEPA
 - This task includes generating a scope of work and schedule for the project, as well as time for meetings and discussions, and preparation of a written outline. Additionally, we will assist Millennium Strategies with Grant writing, as needed.
 - Task 1 Cost Estimate: \$12,000

Work will be billed at VHB's standard hourly rates. This SOS assumes that Millennium Strategies and/or Monmouth Conservation Foundation will complete the grant writing. This SOS is subject to the Terms and Conditions agreed upon in the Work Authorization executed on March 1, 2024.
