BOULEVARD AND CHESTNUT STREET AT BRIDGE AVENUE INTERSECTION
ENGINEERING DESIGN, SURVEY, CONSTRUCTION ADMINISTRATION & INSPECTION

WHEREAS, the Borough Governing Body has identified a need for Pedestrian Intersection Improvement Project (Safe Streets to Transit Grant) Drs. James Parker Boulevard and Chestnut Street at Bridge Avenue Intersection Engineering Design, Survey, Construction Administration & Inspection Services; and

WHEREAS, based on the size and scope of such undertaking, the professional services of the Borough Special Projects Engineer are considered desirable by Borough management; and


WHEREAS, the Mayor and Council (hereinafter, the "Governing Body" of the Borough concur with the sentiments and recommendation of the Borough management and wish to enlist the professional services of the Borough Special Projects Engineer for the necessary services associated with the NJ DOT project here forward known as for Pedestrian Intersection Improvement Project (Safe Streets to Transit Grant) Drs. James Parker Boulevard and Chestnut Street at Bridge Avenue Intersection Engineering Design, Survey, Construction Administration & Inspection Services (6/13/2024 Proposal RBNKOH-16002 T&M);

NOW THEREFORE BE IT RESOLVED, by the Mayor and Council of the Borough of Red Bank, County of Monmouth, State of New Jersey, that a Professional Services Contract for Pedestrian Intersection Improvement Project (Safe Streets to Transit Grant) Drs. James Parker Boulevard and Chestnut Street at Bridge Avenue Intersection Engineering Design, Survey, Construction Administration & Inspection Services; to T&M Associates for the sum not to exceed seventy thousand dollars (\$70,000.00); and,

BE IT FURTHER RESOLVED that this Resolution shall take effect upon certification on this Resolution by the Borough Chief Financial Officer that sufficient funds are available for stated purpose; and

BE IT FURTHER RESOLVED that charges incrementally incurred and paid associated with this contract shall be pursuant to the contract terms authorized in Resolution #24-02 of January 1, 2024.
