A MESSAGE FROM THE FINANCE OFFICE CONCERNING TAXES AND ASSESSMENTS

The Borough of Red Bank collects taxes on behalf of several entities, including the county, county open space, county health tax, local district school, regional school, local municipal purposes, and the municipal library. While the borough has some control over the municipal budget, it does not control the budgets for schools, the library, or the county. The breakdown of collections is as follows: 35.30% for the local school, 25% for the regional school, 26.30% for the municipality, 11.70% for the county, and 1.98% for the library.

In 2024, the tax rate increases for various entities in the Borough of Red Bank were as follows:

- Library Tax Rate Increase (Set Statutorily): 10.98%
- County Tax Rate Increase: 6.61%
- Regional School Tax Rate Increase: 3.56%
- Local School Tax Rate Increase: 2.9%
- Municipal (Local Government) Tax Rate Increase: 2.9%

During this period, total taxable assessments within the borough rose by 4.83%. Property taxes are calculated based on these assessments, which should reflect the current market value as of October 1st each year. The borough's assessor conducts annual evaluations of each property.

For 2024:

- 160 parcels (3.8%) saw a decrease in assessment of at least \$500.
- 2,573 parcels (62.52%) had minimal changes, ranging between -\$500 and +\$500.
- 1,382 parcels (33.58%) experienced an increase in assessment of at least \$500.

If your property's assessment increase is consistent with the overall average, your taxes would increase by approximately 3.64%. The 1st and 2nd quarter preliminary tax bills were based on 50% of the prior year's taxes. The 3rd and 4th quarter final bills were adjusted to reflect the total tax obligation for the year.

For any questions about the assessment of a specific property, please contact our assessor, William Laird, who can provide detailed information on how property values are calculated.

There is also tax relief available for eligible seniors through the Senior Freeze program. To qualify, residents must be 65 or older, have lived in New Jersey for the past 10 years, owned their property for at least three years, and meet certain household income requirements. If eligible, the State will freeze your taxes at the base year amount, and any increase will be reimbursed by the State.

Additionally, you have the option to file a tax appeal with Monmouth County. The appeal is based on the assessment, not the tax amount, and can be done online for 2025. The deadline for filing is January 15th. New assessment cards will be mailed out in November. If your appeal is successful and your assessment is reduced, your tax obligation will decrease in 2025. Brush Collection

The final brush collection of the season will take place in **October** as we transition to leaf collection. We encourage residents to take advantage of this service by placing their brush at the curb on the assigned collection date before the end of October.

After the brush collection concludes in October, our team will begin leaf collection from **November through December**. Leaf collection will continue through the fall, and we will do our best to ensure timely service.

Please remember the following guidelines when preparing your brush and leaves for collection.

- **Do not block fire hydrants:** Keep brush clear of fire hydrants to ensure they are accessible in an emergency.
- **Avoid storm drains:** Please do not place brush over storm drains to prevent any blockages or flooding.
- **Avoid painted yellow areas:** Brush should not be placed in areas painted yellow, as this could obstruct visibility or create safety hazards.

PETS PLANNING

- COME UP WITH SHELTER ALTERNATIVES THAT WILL WORK FOR BOTH YOU AND YOUR PET
- HAVE YOUR PET WEAR HIS OR HER COLLAR WITH RABIES AND IDENTIFICATION TAGS
- MAKE COPIES OF IMPORTANT DOCUMENTS FROM YOUR PET'S VETERINARIAN TO INCLUDE IN YOUR EMERGENCY SUPPLY KIT
- ADD PLASTIC TRASH BAGS AND CLEANING PRODUCTS TO YOUR EMERGENCY SUPPLY KIT TO PROVIDE FOR YOUR PET'S SANITATION NEEDS
- HAVE A CRATE OR PET CARRIER AVAILABLE IN THE CASE OF EVACUATION



WATCH VS. WARNING

WATCH: Tropical Storm or Hurricane conditions are POSSIBLE

Issued 48 hours in advance

WHAT TO DO:

- o Prepare your home for impact
- o Review your evacuation and communication plan
- o Fuel vehicles and go through your emergency supply kit
- o Monitor weather forecast and instructions from local officials

WARNING: Tropical Storm or Hurricane conditions are EXPECTED

Issued 36 hours in advance

WHAT TO DO:

- o Finalize storm preparations to your home
- o Leave warned area immediately if directed by local officials
- o Continue to monitor weather forecast and updates from officials

EMERGENCY PLANNING

DEVELOP AN EVACUATION PLAN:

- Plan your primary evacuation route well ahead of time
- Establish an alternative evacuation route just in case
- Determine where your family will stay during the disaster
- Create a list of essential belongings you intend to bring
- Have a plan for your pets

DEVELOP A COMMUNICATION PLAN:

- Establish a way to get in touch with loved ones
- Designate an emergency meeting place in the case your family becomes separated
- Appoint a friend or family member who is not affected by the storm to be a point of contact
- Have a way to receive the latest weather updates.



AFTER THE STORM

- WAIT TO RETURN TO THE IMPACTED AREA UNTIL LOCAL AUTHORITIES DEEM IT SAFE.
- MAKE SURE THE MAIN ELECTRICAL SWITCH IS OFF BEFORE YOU RE-ENTER YOUR HOME.
- DO NOT DRINK OR USE TAP WATER UNTIL THERE IS CONFIRMATION THAT IT IS NOT CONTAMINATED.
- IF USING AN EMERGENCY GENERATOR, KEEP IT OUTSIDE. NEVER RUN THE GENERATOR IN THE HOUSE OR GARAGE.
- IF YOU COME ACROSS A FALLEN POWER LINE, STAY BACK AT LEAST 500 FEET AND NEVER TOUCH THE LINE.
- BEFORE THE CLEANUP PROCESS BEGINS, TAKE PICTURES TO DOCUMENT THE DAMAGE AND FILE AN INSURANCE CLAIM.
