RESOLUTION AUTHORIZING THE COUNTY OF MONMOUTH MOSQUITO CONTROL DIVISION TO CONDUCT AERIAL MOSQUITO CONTROL OPERATIONS WITHIN THE BOROUGH OF RED BANK, COUNTY OF MONMOUTH, STATE OF NEW JERSEY

WHEREAS, the Monmouth County Board of Chosen Freeholders, pursuant to N.J.S.A. 26:9-27 et seq., has elected through its Mosquito Control Division to perform all acts necessary for the elimination of Mosquito breeding areas and/or to exterminate mosquitoes within the County; and

WHEREAS, the County has instituted an Integrated Pest Management Program consisting of surveillance, water management, biological control and chemical control to exterminate the mosquito population within the County of Monmouth; and

WHEREAS, prior to conducting aerial dispensing operations over a designated “congested area,” the County is required, pursuant to Federal Aviation Administration Regulation (FAR Part 137.51), to secure prior written approval from the Governing Body of the political subdivision over which the aircraft is to be operated; and

WHEREAS, the Borough of Red Bank is designated as a “congested area” by the Federal Aviation Administration and the County has requested that this Governing Body consent to its proposed aerial dispensing operations.

NOW, THEREFORE, BE IT RESOLVED as follows:

1. The Governing Body of the Borough of Red Bank hereby authorizes the County of Monmouth Mosquito Control Division or its agent to apply pesticides by aircraft for mosquito control in certain areas of the municipality designated by the County as being either larval mosquito habitat or areas harboring high populations of mosquitoes constituting either a nuisance, a health hazard or both with the understanding that:
 - a. The County shall utilize pesticides, application equipment and aircraft that are approved for aerial applications by applicable Federal (USEPA) and State (NJDEP) agencies, and
 - b. Such operations will be performed in compliance with applicable Federal and State regulations, and
 - c. The County will notify the Police Department of each municipality over which aerial pesticide operations are planned prior to commencement of such operations.

BE IT FURTHER RESOLVED that the Clerk forward a certified true copy of this Resolution to the Monmouth County Mosquito Control Division, 1901 Wayside Road, Tinton Falls, NJ 07724, Attn: Victoria Thompson, Superintendent.

COUNTY OF MONMOUTH, STATE OF NEW JERSEY TO THE
MONMOUTH COUNTY IMPROVEMENT AUTHORITY, AND
DETERMINING VARIOUS MATTERS IN CONNECTION
THEREWITH**

WHEREAS, the Borough of Red Bank, in the County of Monmouth, State of New Jersey (the “Borough”) has heretofore adopted, from time to time, various bond ordinances (the “Bond Ordinances”) authorizing various capital improvements, and the issuance and sale, from time to time, of its bonds and bond anticipation notes in order to finance such capital improvements; and **WHEREAS**, the Bond Ordinances authorize the Chief Financial Officer to sell any bond anticipation notes thereunder at public or private sale, as determined by the Chief Financial Officer; and

WHEREAS, the Borough has applied to The Monmouth County Improvement Authority (the “MCIA”) to participate in its pooled governmental note financing program (the “Program”); and

WHEREAS, under the Program, the MCIA will issue and sell its pooled notes (the “MCIA Notes”), which MCIA Notes will be secured by (i) payments from various governmental entities located in Monmouth County (including the Borough) under various notes issued by such governmental entities to the MCIA, and (ii) the unconditional guaranty of the County of Monmouth, State of New Jersey (the “County”); and

WHEREAS, on January 8, 2025, the New Jersey Local Finance Board held a hearing and issued positive findings in respect of the issuance of the MCIA Notes by the MCIA and its approval of the guaranty of the MCIA Notes by the County; and

WHEREAS, the Borough wishes to participate in the Program, and to issue and sell all or a portion of its not to exceed \$8,435,000 Bond Anticipation Notes, Series 2025 consisting of not to exceed \$6,131,000 General Improvement Notes, Series 2025 and not to exceed \$2,304,000 Water-Sewer Utility Notes, Series 2025 to the MCIA; and

WHEREAS, the Borough will receive a proposal for the purchase of such bond anticipation notes from the MCIA, which purchase will be effected through a note purchase agreement (the "Note Purchase Agreement") to be entered into by and between the Borough and the MCIA; and

WHEREAS, the Borough acknowledges that the MCIA intends to execute a contract of purchase with an underwriter pertaining to the sale of the MCIA Notes, the proceeds of which shall be used by the MCIA, *inter alia*, to purchase the such bond anticipation notes of the governmental entities participating in the Program, including Borough; and

WHEREAS, the Borough now wishes to authorize the issuance and sale of all or a portion of its bond anticipation notes to the MCIA;

NOW, THEREFORE, BE IT RESOLVED BY THE BOROUGH COUNCIL OF THE BOROUGH OF RED BANK, IN THE COUNTY OF MONMOUTH, STATE OF NEW JERSEY, as follows:

SECTION 1. The above recitals are incorporated herein as though fully set forth at length.

SECTION 2. The Chief Financial Officer is hereby authorized to cause all or a portion of the Borough's not to exceed \$8,435,000 Bond Anticipation Notes, Series 2025 consisting of not to exceed \$6,131,000 General Improvement Notes, Series 2025 and not to exceed \$2,304,000 Water-Sewer Utility Notes, Series 2025 (the "Program Notes") to be issued and sold to the MCIA in accordance with the Program.

SECTION 3. The terms and conditions of the sale of the Program Notes to the MCIA shall be set forth in the Note Purchase Agreement to be dated on or about the date of pricing of the MCIA Notes. The execution and delivery by the Mayor, the Business Administrator or the Chief Financial Officer of the Borough (each, an "Authorized Officer") of the Note Purchase Agreement, in such form as shall be approved by such officer, is hereby authorized; such approval to be conclusively evidenced by such officer's execution thereof.

SECTION 4. The Borough hereby authorizes the use of certain information concerning the Program Notes and the Borough in the Preliminary Official Statement and final Official Statement of the MCIA, to be used in connection with the marketing and sale of the MCIA Notes.

SECTION 5. The execution and delivery by an Authorized Officer of a Continuing Disclosure Agreement, if required, to be dated as of the date of closing of the MCIA Notes, between the Borough and the trustee for the MCIA Notes, in such form as shall be approved by such Authorized Officer, is hereby authorized; such approval to be conclusively evidenced by such officer's execution thereof.

SECTION 6. A portion of the proceeds from the sale of the Program Notes to the MCIA may be retained by the MCIA as payment for the Borough's allocable share of issuance expenses related to the issuance of the MCIA Notes and expenses related to the County Guaranty. Any

Authorized Officer is hereby authorized and directed to pay from the proceeds of the Program Notes, all of the costs associated with the sale and issuance of the Program Notes.

SECTION 7. The Authorized Officers and any other officer of the Borough, and the staff and consultants of the Borough, including Wilentz, Goldman & Spitzer, P.A., bond counsel to the Borough, are hereby authorized and directed to take all actions and execute any other agreement, certificate, document or instrument which may be necessary or convenient to effectuate the terms of this resolution in connection with the issuance, sale and delivery of the Program Notes, which includes the review and delivery of a preliminary official statement and official statement on behalf of the Borough, and the execution of the Note Purchase Agreement, the Continuing Disclosure Agreement, if any, and any other agreement, certificate, document or instrument to be executed in connection with the issuance of the Program Notes or the MCIA Notes.

SECTION 8. This resolution shall take effect immediately.

WHEREAS, the Borough of Red Bank, County of Monmouth, State of New Jersey (the “Borough”) has filed a declaratory judgment action in accordance with the compliance process mandated by the New Jersey Supreme Court; and

WHEREAS, the Borough requires additional professional planning services in connection with the court-mandated compliance process; and

WHEREAS, to date, the Borough has adopted all required documentation in accordance with the Settlement Agreement with Fair Share Housing Center, and the Special Master has issued a report recommending the Court grant the Borough a Final Judgment of Compliance and Repose, with immunity through 2025; and



**RESOLUTION IN SUPPORT OF NJ CLIMATE SUPERFUND ACT
MUNICIPAL RESOLUTION**

WHEREAS, the proposed "NJ Climate Superfund Act" (S3545 / A4696), pending before the New Jersey Legislature would impose liability on large fossil fuel companies for certain climate change related damages they caused instead of imposing all those costs on New Jersey taxpayers; and

WHEREAS, New Jersey has experienced deaths and billions of dollars in losses from storms linked to climate change. Hurricane Sandy costs are estimated to be over \$29 billion, along with 38 deaths, while Hurricane Ida caused about \$2 billion in costs and 30 deaths. From 1980–2024 (as of November 1, 2024), there have been 74 confirmed weather/climate disaster events with losses exceeding \$1 billion each to affect New Jersey. These costs do not include many others associated with climate change listed below; and

WHEREAS, total global GDP today is about \$100 trillion and "climate change is on track to cost the global economy \$38 trillion every year in damages within the next 25 years;" and

WHEREAS, a 2023 report found that extreme climate events cost the U.S. \$150 billion each year, excluding costs related to loss of life, healthcare, and ecosystem damage. The 2024 catastrophic flooding and destruction caused by Hurricane Helene in western North Carolina alone likely caused at least a record \$53 billion in damages and recovery needs; and

WHEREAS, the effects of climate change on New Jersey municipalities include but are not limited to increases in the costs of property insurance, flooding (including clean ups, property buyouts and prevention), public health care costs (costs from injuries, heat, dealing with vector borne diseases and insurance), repair to critical infrastructure such as roads, bridges, sewer systems and wastewater management, installing/maintaining air conditioning in schools, costs of dealing with forest fires and resulting property damages, increased costs of water purification from droughts or floods, seawall and other protections against ocean flooding, raising roads to prevent sunny-day flooding, potential lawsuits from residents, loss of tax revenue from destroyed properties, salt water invasion of aquifers, algal blooms, loss of recreation/tourism revenue, dealing with insect and other infestations; and

WHEREAS, more than 50 years ago, scientists at major fossil fuel companies knew of the direct link between fossil fuels and global warming and reported their findings to corporate executives, who chose to deceive the public about climate science, downplay and distort the evidence of climate change, engage in a decades-long campaign against climate action, fund counterfeit science, and manufacture uncertainty with no scientific basis; and

WHEREAS, the TOP 25 oil and gas 'carbon majors' have continually earned enormous profits and have the ability to pay for their share in damages and remain extremely profitable. Global climate damages from emissions associated with the top 25 oil and gas 'carbon majors' between 1985 and 2018 are estimated at 20 trillion USD compared to the 30 trillion USD they earned over the same period. In 2022 seven carbon majors including Aramco, Exxon Mobil, and Shell earned profits almost twice the estimated damages caused by their emissions that year – 497 billion USD compared to 260 billion USD; and

WHEREAS, the Climate Superfund Act seeks to hold "responsible parties," which is defined as large fossil fuel companies operating in New Jersey and were responsible more than one billion metric tons of greenhouse gas emissions since 1994, liable for the past, current and future costs of funding climate change adaptation and resilience projects instead of placing the burden on New Jersey taxpayers; and

WHEREAS, the State Treasurer will be authorized under this Act to determine the cost impacts of these greenhouse gas emissions on the State, including effects on public health, natural resources, biodiversity, agriculture, economic development, flood preparedness and safety, housing, and any other effect that the State Treasurer determines is relevant; and

WHEREAS, a Climate Superfund Cost Recovery Program will be established under this Act by the NJDEP to obtain compensatory payments from Responsible Parties and accept and collect payment from responsible parties and to disburse those funds for "climate change adaptation projects;" to project sponsors of climate change adaptation and resilience projects; and

WHEREAS, "climate change adaptation projects" include, but are not limited to: flood protection projects; home buyouts; upgrades of stormwater drainage systems; defensive upgrades to roads, bridges, railroads, and transit systems; preparation for, and recovery from, extreme weather events; preventive health care programs and providing medical care to treat illness or injury caused by the effects of climate change; relocation, elevation, or retrofits of sewage treatment plants and other infrastructure vulnerable to flooding; installation of energy efficient cooling systems and other weatherization and energy efficiency upgrades and retrofits in public and private buildings, including schools and public housing, designed to reduce the public health effects of more frequent heat waves and forest fire smoke; upgrades to the electrical grid to increase stability and resilience, including the creation of self-sufficient microgrids; and response to toxic

algae blooms, loss of agricultural topsoil, crop loss, and other climate-driven ecosystem threats to forests, farms, fisheries, and food systems; and

WHEREAS, any municipality in need of climate change adaptation and resilience projects will be able to apply for the funds raised by the Act; and

WHEREAS, the total funds to be recovered under this Act is expected to be multiple billions of dollars each year;

WHEREAS, economists agree that the design of the Act would not cause costs to be passed along to consumers because 1) the payments would be based on past pollution and, therefore, not affect today's marginal cost of production; and 2) the price of fossil fuels is based on international market forces; and

WHEREAS, the Act would not preclude municipalities from filing and paying for their own lawsuits in order to obtain payment for damages caused by climate change emissions; and

WHEREAS, the Act will make New Jersey more affordable by not saddling New Jersey taxpayers with the large and rapidly increasing costs of paying for climate damages

THEREFORE, BE IT RESOLVED that the administration and town council of the Borough of Red Bnak, in the interest of protecting its residents, businesses and institutions, as of February 13, 2025, strongly express their support for passage of the NJ Climate Superfund Act.





This Contract for Professional Services (the “Contract”) is entered into by and between the Borough of Red Bank, 90 Monmouth Street, Red Bank, NJ 07701 (the “Borough”) and P.U.L.S.S.E. Services, 9 Oxford Road, Jackson, NJ 08527 (the “Contractor”). The Borough and the Contractor are referred to collectively as the “Parties.”

WHEREAS, the Borough seeks to enter into a Professional Service Contract for a Licensed Clinical Social Worker to establish a community crisis response to calls for service received by the Borough and its Police Department where substance abuse, addiction, mental and/or behavioral health are the reported issues; and

WHEREAS, by Request for Proposals, dated August 10, 2023, the Borough previously solicited proposals through a fair and open process under N.J.S.A. 19:44A-20.5 et seq.; and

WHEREAS, the Contractor submitted a Proposal, dated September 3, 2023, indicating it was willing and able to provide the needed Licensed Clinical Social Worker services; and

WHEREAS, the Contractor’s credentials were evaluated by the Borough and the Contractor was found to meet all requirements and criteria to provide the aforesaid services; and

WHEREAS, by Resolution of Award, dated September 14, 2023, the Borough awarded a Professional Service Contract to the Contractor for Licensed Clinical Social Worker services, and the Contractor has ably and satisfactorily provided the aforesaid services to the Borough since October 1, 2023; and

WHEREAS, given the Contractor’s satisfactory performance and its success in providing the aforesaid services within the Borough, the Contractor and the Borough mutually desire to renew their Professional Service Contract until at least September 30, 2025;

NOW, THEREFORE, the Parties have agreed to contract for Licensed Clinical Social Worker services as follows:

1. **Contract Documents.** The Borough’s prior advertised Request for Proposals, dated August 10, 2023; the Contractor’s Proposal, dated September 3, 2023; and the Borough’s Resolution of Award, dated February 13, 2025, are hereby incorporated by reference into this Contract in their entirety.

2. **Term.** The term of this Contract shall commence on October 1, 2024 and shall expire on September 30, 2025.

3. **Payment.** For all Licensed Clinical Social Worker services provided under this Contract, the Borough shall compensate the Contractor at a billable rate of \$105.00 per hour, not to exceed \$65,520.00 during the term of this Contract.

4. Scope of Services. The Contractor shall provide Licensed Clinical Social Worker services to the Borough and its Police Department, as required and requested by the Borough. The Contractor shall work with the Borough and its Police Department to establish a community crisis response to calls for service received by the Borough and its Police Department where substance abuse, addiction, mental and/or behavioral health are the reported issues. It is anticipated that the Contractor will provide three 4-hour shifts per week in connection with its provision of Licensed Clinical Social Worker services, but the exact schedule and hours will be determined by the Parties, as needed, during the term of this Contract.

5. Invoices and Payment. On the first day of each month following the date of this Contract, or as soon thereafter as practicable, the Contractor shall provide the Borough with an invoice for all services provided by the Contractor to the Borough during the preceding month. The Contractor shall comply with all payment policies and procedures required by the Borough.

6. Termination. Either party may terminate this Contract at any time by providing thirty (30) days written notice to the other party.

7. Integration Clause. This Contract represents and contains the entire agreement and understanding with respect to the subject matter of this Contract, and supersedes any and all prior oral and written agreements and understandings, and no representation, warranty, condition, understanding or agreement of any kind with respect to the subject matter hereof shall be relied upon by the Parties hereto unless incorporated herein. This Contract may not be amended or modified except by an agreement in writing signed by the party against whom the enforcement of any modification or amendment is sought.

8. Representation of Comprehension. The Parties represent to each other that they have completely read this Contract, fully understand its terms and voluntarily accept same of their own choice. The Parties further represent and acknowledge that they have been provided with the opportunity to review this Contract with independent legal counsel.

9. Construction. In the event that one or more of the provisions or portions of this Contract is determined to be illegal or unenforceable, the remainder of this Contract shall not be affected thereby and each remaining provision or portion thereof shall continue to be valid and effective and shall be enforceable to the fullest extent permitted by law. This Contract is entered into in the State of New Jersey and shall be construed and interpreted in accordance with its laws. This Contract may be executed in any number of counterparts, each of which shall be deemed to be an original and all of which together shall be deemed one and the same instrument.

10. Who Is Bound. The Parties are bound by this Contract. Any person or entity who succeeds to their respective rights and responsibilities is also bound.

WHEREAS, Riverview Medical Center (“RMC”) seeks to improve emergency services on its campus located within the Borough of Red Bank (the “Borough”); and

WHEREAS, RMC seeks to create new access to its emergency care center (“ECC”), improve vehicular and pedestrian circulation adjacent to the ECC, and upgrade the critical emergency backup power system for RMC’s campus; and

WHEREAS, the proposed project includes a new generator to provide backup power to RMC in times of crisis, which will be located behind the hospital near other utility services in order to maintain vehicular circulation, to minimize the impact to overall parking supply, and to avoid potential environmental impacts; and

WHEREAS, the proposed project also includes adding exterior access to the ECC, extending a portion of an existing canopy, and improving the vehicular drop-off area; and

WHEREAS, in support of its onsite improvements, there are also minor improvements proposed by RMC within the Union Street right-of-way (“ROW”), which ROW is under the authority and control of the Borough; and

WHEREAS, given the proximity of the proposed improvements to the Navesink River, RMC also requires approval under the Coastal Area Facility Review Act (“CAFRA”) from the New Jersey Department of Environmental Protection (“NJDEP”); and

WHEREAS, to accelerate the timeline of its planned improvements, RMC intends to submit its application to the NJDEP for a CAFRA permit in advance of, or simultaneously with, its application for land use approvals to the Borough; and

WHEREAS, insofar as RMC proposes minor improvements within the Borough’s ROW, RMC requires the Borough’s execution of its CAFRA permit application in order to be deemed administratively complete by the NJDEP; and

WHEREAS, the Borough’s execution of RMC’s CAFRA permit application does not prejudice the Borough as to, nor relieve RMC from further seeking and obtaining, any and all land use approvals further required by the Borough in connection with the proposed project; and

WHEREAS, all costs and expenses associated with RMC's CAFRA permit application shall be the sole responsibility of RMC, and not the Borough; and

WHEREAS, the Borough otherwise finds RMC's request for the Borough's execution of RMC's CAFRA permit application to be acceptable and appropriate under the circumstances;

NOW THEREFORE, BE IT RESOLVED, that the Mayor & Council of the Borough of Red Bank hereby authorize the Borough Manager to execute RMC's CAFRA permit application for the above-described project; and

BE IT FURTHER RESOLVED, that a certified copy of this Resolution be forwarded to the Borough Manager, Borough Engineer, Director of Community Development, and RMC.

**RESOLUTION INCREASING SPECIAL DUTY ASSIGNMENT RATES CHARGED TO
PRIVATE PARTIES BY RED BANK BOROUGH POLICE OFFICERS UNDER
ARTICLE III: "SPECIAL DUTY ASSIGNMENTS FOR POLICE OFFICERS" WITHIN
CHAPTER 118: "POLICE DEPARTMENT" OF THE BOROUGH'S REVISED
GENERAL ORDINANCES.**

WHEREAS, the officers of the Red Bank Borough Police Department are frequently called upon to work during their off-duty time for particular needs; and

WHEREAS, these special duty assignments are authorized and regulated by the Borough within Article III: "Special Duty Assignments for Police Officers" of Chapter 118: "Police Department" of the Borough Code; and

WHEREAS, the current special duty rate of the Borough must presently be adjusted to remain competitive and in line with rising costs associated with providing such services; and


WHEREAS, the hourly cost associated with an special duty assignment consists of three parts: (i) the hourly amount which the officer is paid as determined by the Governing Body with advice of the Borough Manager; (ii) administrative costs which are incurred by the Borough for each hour that an officer works a special duty assignment; and (iii) costs incurred for the wear and tear on utilized Borough police vehicles; and

WHEREAS, the Governing Body, with the advice of the Borough Manager, has determined that it is appropriate to increase both the hourly rate and administrative fee to be paid by a private entity requesting the services of the Red Bank Police Department;

NOW THEREFORE, BE IT RESOLVED, by the Mayor & Council of the Borough of Red Bank that, effective as of January 1, 2025 for all Special Duty Assignments, the rate charged by the Borough for each hour that a Red Bank Police Officer works a Special Duty Assignment shall be ninety dollars (\$90.00) per hour, and the administrative fee shall be an additional twenty dollars (\$20.00) per hour, so that the total hourly rate for a Red Bank Police Officer assigned a Special Duty Assignment in accordance with Borough Code Chapter 118 shall be one-hundred and ten dollars (\$110.00) per hour.

9. Deliberations which may result in the imposition of civil penalty or the suspension or loss of license or permit;

Item # 5, Matters involving acquisition of real property with public funds, or investment of public funds, where disclosure would jeopardize such acquisition or investment
