**ORDINANCE AMENDING CHAPTER 680: "VEHICLES AND TRAFFIC"
TO REVISE TIME-LIMITED PARKING REGULATIONS ON THE
SOUTH SIDE OF DRS. JAMES PARKER BOULEVARD**

WHEREAS, the Borough of Red Bank (the "Borough") has received a recommendation from its Police Department to reduce the restricted parking area on the south side of Drs. James Parker Boulevard to create additional parking;

NOW, THEREFORE, BE IT ORDAINED by the Mayor and Council of the Borough of Red Bank, County of Monmouth, State of New Jersey, that Chapter 680: "Vehicles and Traffic" of the Borough's Revised General Ordinances is hereby amended as follows (~~stricken~~ text deleted; underlined text added):

ARTICLE V: SCHEDULES

§680-37 Schedule III: No Stopping or Standing.

In accordance with the provisions of § 680-3E of this chapter, no person shall stop or stand a vehicle between the hours specified upon any of the following described streets or parts of streets.

All other provisions of the Revised General Ordinances are ratified and remain in full force and effect.

BE IT FURTHER ORDAINED by the Mayor and Council of the Borough of Red Bank that if any provision of this Ordinance or the application of such provision to any person or circumstance is declared invalid, such invalidity shall not affect the other provisions or applications of this Ordinance which can be given effect, and to this end, the provisions of this Ordinance are declared to be severable.
