PICK UP SCHEDULE 2026

LEAVES



2nd full week of the month
November – December

Zone 1 Monday
Zone 2 Tuesday
Zone 3 Wednesday
Zone 4 Thursday
Zone 5 Friday

Only leaves will be collected – piles with debris other than leaves cannot be collected because of restrictions placed on the Borough. Residents are reminded not to block catch basins to minimize flooding.

BRUSH



2nd full week of the month
April–October.

Collection: Place leaves and brush at the curb only during scheduled periods.

TRASH COLLECTION

East of Broad Street
Monday & Thursday

West of Broad Street
Tuesday & Friday

NOTE: There will be **NO** sanitation **pickup** on January 1st, November 26th, or December 25th

TRASH HOLIDAY COLLECTION:

There will be no waste collection on New Year's Day, Thanksgiving Day, and Christmas Day. Should a regular collection date fall on one of these holidays, collection shall be on the next regular business day.

RECYCLING

Single-stream recycling is collected curbside **every Wednesday** by a third-party contractor. Questions? Call DeLisa Waste Services: (732) 988-2525

BULK WASTE

Once a month

East of Broad St. **2nd Thursday**

West of Broad St. **3rd Friday**

Place no more than 2 items at the curb before 6 a.m. the day of and no sooner than 6 p.m. the day before collection.
(Ord. #590-15 (f))

CHRISTMAS TREE DISPOSAL

Curbside collection: **January 1 through the second week of February** (weather permitting).

Please remove all decorations, ornaments, tinsel, and light strands. Artificial trees will not be collected.

Schedules & Restrictions will be strictly enforced. Summons will be issued for piles placed at the curb violating ordinances.



IMPORTANT REMINDERS

Trash Collection

Trash collection is provided weekly, curbside, through a third-party contractor.

Borough ordinances allow up to three (3) 32-gallon/50-pound receptacles per single family. Plastic bags may be used if placed inside the receptacles.

Recycling Collection

- Limit: Borough ordinances allow one 35-gallon receptacle per single-family residence.
- Accepted Items: Glass bottles and jars, metal cans, mixed paper, cardboard, and plastics #1, #2, and #5.
 - Cardboard must be flattened and tied.
 - Pizza boxes accepted if non-contaminated only.
- Preparation: Items must be clean, dry, and empty.
- Plastic bags are prohibited and will result in non-collection.

Why It Matters: Recycling reduces trash disposal costs and helps the Borough earn money through recycling tonnage grants, which are based on the amount of material recycled each year.

Fall Leaf Collection

Leaf Collection (Nov–Dec):

Collection begins in November. Place leaves loose or in biodegradable bags no earlier than seven days before your scheduled pickup. (Ord. §590-17C) Piles must not block traffic or create safety hazards; in such areas, bagging is required.

Brush Collection:

- Collected April–October.
- Placement: Brush may not be set out earlier than seven (7) days prior to a scheduled and announced collection. (Ord. §590-17.B)
- Size Limits: Tree limbs and branches must be placed loose at the curb. No piece may exceed 4 feet in length or 3 inches in diameter. Piles may not exceed 3 feet in height, extend more than 2 feet into the roadway, or exceed 2 cubic yards. (Ord. §590-17.B)
- Debris Restrictions: Brush must be free of other debris or solid waste. Brush is collected only on dates and times designated by the Department of Public Utilities.
- Contractor Restrictions: Contractors, subcontractors, and similar parties are prohibited from placing brush, solid waste, recyclables, furniture, bulky waste, large household appliances, light metal, or other items for collection. (Ord. §590-15.B[2])



IMPORTANT REMINDERS

HYDRANT FLUSHING (SPRING & FALL)

Each spring and fall, fire hydrants are systematically opened to flush the water system.

This process:

- Improves water quality by removing sediment
- Verifies hydrant and valve operation
- Ensures hydrants are ready for fire emergencies

During flushing, you may notice discolored water. This is normal and not harmful. Run your tap until the water clears and avoid doing laundry until it does.

STORMWATER

The State of New Jersey requires municipalities to adopt rules to reduce stormwater pollution and protect our water supply. With the Navesink River as our shoreline, Red Bank is proud to be an active participant.

- Yard Waste (i.e. Leaves, grass clippings, weeds, flowers, and brush): Residents may not sweep, rake, blow, or place loose yard waste (at the curb, along the street, or within 10 feet of a storm drain inlet more than 7 days before a scheduled pickup. (Ord. #434-8)

NOTE:

Electronic Waste Recycling

Due to a statewide ban, electronic items — including computers, televisions, monitors, phones, speakers, and similar devices — cannot be placed curbside for pickup.

E-waste must be recycled at the Red Bank Recycling Center on West Sunset Avenue, where a dedicated container is available for disposal.

Grass Clippings

Ord No. § 590- 17. E Grass clippings will not be collected. Grass clippings shall at no time be placed loose or in containers at the curb. The Borough promotes a "cut it and leave it" policy.

Water & Sewer Line Upgrades

Homeowners may request a water and/or sewer line upgrade by calling 732-858-8143 for a quote or email: ymacdonald@redbanknj.org.

You should receive a quote in the mail within 10 days. All quotes are good for 90 days.

Household Hazardous Waste

Items that cannot be collected with trash, recycling, or bulk waste may be accepted at the Monmouth County Household Hazardous Waste Facility.
