**Community Emergency Response Team**

Council President Murphy said there were six individuals who had completed training to serve on a Community Emergency Response Team (CERT) and he thanked them for their efforts. He introduced Emergency Management Coordinator Tom Welsh and Deputy Emergency Management Coordinator Ernie Van Pelt. They presented certificates of completion to the CERT members.

**Red Bank Middle School Athletic Foundation**

Gene Horowitz—118 Branch Avenue—said he was appearing on behalf of the Red Bank Middle School Athletic Foundation. He said he had four children, two of which were in the Middle School. He explained the athletic programs offered by the school and noted that the sports budget had been cut. He said, in an effort to keep the programs available, they started a non-profit and noted that many who helped did not have children in the school. He thanked Councilman DuPont in particular for his assistance. He added that the athletic programs were funded for this school year, but the future remained uncertain. He said he was appearing to express his gratitude for the support of the Community.

Council President Murphy thanked him for his efforts.

#### **REPORTS OF MAYOR AND COUNCIL MEMBERS**

Councilman DuPont thanked the members of the Finance Committee for their great work in getting the budget done. He said Council members Zipprich and Lewis were instrumental in crafting the budget and in suggesting ideas to increase revenue and reduce expenses. He added that it was a testament to the Borough's fiscal responsibility that one of the purchasers in the Borough's recent emergency note sale was the Township of East Brunswick. He said he felt it was validation from another municipality that they felt Red Bank's notes were a good investment opportunity. He said he also wanted to offer accolades to Administrator Sickels and CFO Lapp for their work on the budget.

Councilman Zipprich reported that the Historic Preservation Commission had met and discussed the possibility of hosting an open forum for residents of historic homes. He said it would afford those residents an opportunity to speak with an expert on Historic Preservation. He said the Public Works Committee had also met and discussed summer park maintenance, water treatment facilities and the 2011/2012 road program. He also noted the Engineer had been present to discuss the project at the lift station.

Councilwoman Horgan reported that the Human Relations Advisory Committee (HRAC) had met and discussed Red Bank's first Pride Event scheduled for June 20. She noted that she, Councilman Zipprich and HRAC Chair David Pascale, the Two River Theater and the Monmouth County Consortium for LGBT Youth would hold the event from 6 to 9 pm at the Two River Theater. She noted it was the first year for the event but that they were hoping it would be an annual event.

Councilman Zipprich added that the event was youth-focused was an outgrowth of the It Gets Better Project.

Councilwoman Lee offered an update on the Library's summer programs. She said they were designed to engage young people and small children. She noted that had recently had a K9 demonstration with the local police department. She said they were scheduling a lot of programs at 4:30 pm so parents could bring children in the afternoon. She also reported that she had attended the Bridge Naming Ceremony for the Captain Joseph Azzolina Bridge on Route 36 connecting Atlantic Highlands to Sea Bright. She said it was a beautiful, well attended ceremony and it had been her honor to represent Red Bank. She also mentioned the importance of the contributions of the Scaduto/Azzolina family to the development of Red Bank.

Councilman Murphy said he also wanted to thank CFO Lapp for her efforts with the budget as well as the Borough's Department Heads and Employees. He noted it was the fourth year that Borough had remained under the two percent cap and he thanked everyone again for their cooperation. He also reported that the Borough would be hosting a Memorial Day Service sponsored by the Parks and Recreation Department. He said it would be held on Monday, May 28 at 11 am in front of the Veteran's Monument at 51 Monmouth Street. He also noted the Parks and Recreation Department had announced that there were only three benches remaining for sponsorship in Marine Park and gave details on cost and how to apply. In addition, he continued, the Red Bank

Volunteer Fire Department had a limited number of bricks available for sponsorship. He noted they were available in two sizes and would be inscribed and placed at the Department's Fallen Firefighter Memorial in front of the Municipal Building at 90 Monmouth Street. He said he also wanted to report that the Fire Department would have a Memorial Day service in front of their monument at 10 am on Monday, May 28, that would include the dedication of a 911 Monument fashioned from a piece of steel received from the World Trade Center.

Councilwoman Lee noted that the Library would have holding a Memorial Day function at 12 noon on Monday.
