Councilman DuPont said the resolution would utilize trust fund balances cancelled in Resolution 10-29, reduce employee furloughs from ten furlough days to three and reinstate Saturday parking revenue. He said it would also include the giveback of police uniforms that was negotiated for 2010, reduce landfill costs, reduce the Streets and Roads salaries, eliminate all new hires budgeted for DPW and eliminate two part time positions.

Councilman Zipprich offered a motion to approve the resolution, seconded by Councilman DuPont.
