**AUDIENCE**

Lorraine Petrick – 28 Riverside Ave. – also business owner – would like to see foot patrols downtown and also asked for a program to clean up the graffiti downtown.

Councilman Hintelmann said he would bring her concerns to the Chief of Police.

Councilwoman Beck said that Chief Clayton had met with members of RiverCenter regarding their concerns on this matter and believes that fines were issued to several individuals.

Mr. Sickels said that two arrests were made.

Councilman Menna suggested that we start foot patrols and also look into video surveillance. He said there might be funding available from the state for the video equipment.

Chris Cole – 1 Fisher Place – said that he had met with Chief Clayton regarding this problem and said RiverCenter sent out information in the Street Beat about the graffiti problem. He said RiverCenter is getting an estimate for painting and is offering a \$500. reward for any information leading to arrest of the individuals painting the graffiti on the buildings.

Councilwoman Thompson said that some police action should be taken and suggested that the business owners call the police when they see any suspicious individuals and suggested the store owners stay opened longer since most of the graffiti is done between 7-9 p.m

Councilman Menna asked the Borough Attorney to see if the state had amended the graffiti statue. He said he thought they were changing the penalty amounts.

Councilman Hintelmann said they would see more police presence on Broad Street.

Councilwoman Beck suggested foot patrols also be added to Shrewsbury Avenue.

Brian Benchman – 44 Irving Place – said there was graffiti painted on the side of his truck and he will offer another \$500. to the award offered by RiverCenter. He also asked that something be done to stop the speeding on Irving Place.

Councilman Hintelmann said he would talk to Chief Clayton about setting up radar on Irving Place.
