

**ORDINANCE 2017-37**

**ORDINANCE OF THE BOROUGH OF RED BANK, COUNTY OF MONMOUTH,  
NEW JERSEY AMENDING AND SUPPLEMENTING THE ORDINANCES  
OF THE BOROUGH OF RED BANK, CHAPTER 64 FIRE DEPARTMENT,  
ARTICLE VI: LENGTH OF SERVICE AWARDS PROGRAM**

Councilman Whelan offered the following ordinance and moved its adoption:

**BE IT ORDAINED** by the Governing Body of the Borough of Red Bank that Chapter 64 the Revised General Ordinances of the Borough of Red Bank, Monmouth County, "Fire Department," Article VI: "Length of Service Awards Program" is hereby amended and supplemented effective January 1, 2017 as follows:

**SECTION ONE:**

- a. Section 64-38, "LOSAP Point System Schedules, annual list of eligible members" is amended and supplemented as follows:

Each active volunteer member shall accrue and be credited with points, to be totaled on an annual basis per calendar year, for volunteer services provided as per the Borough of Red Bank LOSAP Point System Schedules set forth herein as part of this article. The Fire Department and First Aid Rescue Squad shall at the conclusion of each calendar year provide a list and recommendation as to the members achieving the required 50 points of service and the basis for that recommendation. The governing body will thereafter make the determinations to the members on the list as to compliance with the eligibility requirement for each calendar year in accordance with NJAC 5:30-14 et. seq.

**SECTION TWO:** Section 64-38, "LOSAP Point System Schedules, annual list of eligible members" is hereby amended by revising the LOSAP Point System schedule incorporated into the ordinance so that hereafter the schedule shall read as and attached hereto and incorporated herein.

**SECTION THREE:** Any ordinances or portions thereof which are inconsistent with the provisions of this Ordinance are hereby repealed.

**SECTION FOUR:** If any provision of this Ordinance or the application of such provision to any person or circumstance is declared invalid, such invalidity shall not affect the other provisions or applications of this Ordinance, which can be given effect, and to this end, the provisions of this Ordinance are declared to be severable.

**SECTION FIVE:** This Ordinance shall take effect immediately upon adoption and publication in accordance with Law.
