

ORDINANCE NO. 2016-22

ORDINANCE AMENDING AND SUPPLEMENTING CHAPTER 680,
“VEHICLES AND TRAFFIC,” ARTICLE 1 “PARKING AND TRAFFIC,” SECTION 680-3 D.
“PARKING PROHIBITED DURING CERTAIN HOURS ON CERTAIN STREETS” SCHEDULE
II, “PARKING PROHIBITED CERTAIN HOURS.”

Councilman Zipprich offered the following resolution and moved its adoption:

BE IT ORDAINED by the Governing Body of the Borough of Red Bank that Chapter 680 of the Revised General Ordinances of the Borough of Red Bank, Monmouth County, “VEHICLES AND TRAFFIC,” Article 1 “PARKING AND TRAFFIC,” Section 680-3 D., “Parking Prohibited During Certain Hours on Certain Streets,” Schedule II, “Parking Prohibited Certain Hours,” is hereby amended and supplemented as follows:

SECTION ONE: Schedule II, “Parking Prohibited Certain Hours,” is amended and supplemented as follows: (*strikeouts denote deletions, underlined text denotes additions*):

SCHEDULE I
No Parking

In accordance with the provisions of Subsection 680-3 D., no person shall park a vehicle at during certain times on any of the following described streets or parts of streets.

Name of Street	Side	Hours	Location
<u>Spring Street</u>	<u>West</u>	<u>9AM-11AM Mondays</u> <u>and Thursdays</u>	<u>Starting at a point 675 feet south of the intersection of Highland Avenue and Spring Street and running south for a distance of 275 feet.</u>

[All other provisions remain unchanged]

SECTION TWO: Any ordinances or portions thereof which are inconsistent with the provisions of this Ordinance are hereby repealed as of the effective date of this Ordinance.

SECTION THREE: If any provision of this Ordinance or the application of such provision to any person or circumstance is declared invalid, such invalidity shall not affect the other provisions or applications of this Ordinance which can be given effect, and to this end, the provisions of this Ordinance are declared to be severable.

SECTION FOUR: This Ordinance shall take effect immediately upon its passage and adoption according to law.
