

ORDINANCE NO. 2015-25

**ORDINANCE AMENDING AND SUPPLEMENTING CHAPTER VIII, "PARKING LOTS and  
HANDICAPPED SPACES", Section 8-2.6, "PERMIT PARKING", OF THE REVISED  
GENERAL ORDINANCES OF THE BOROUGH OF RED BANK**

offered the following ordinance and moved its introduction on first reading:

**WHEREAS**, the Mayor and Council of the Borough of Red wish to establish uniform design standards for the permit parking signage within the Borough that will make the signs easy to read and understand.

**NOW THEREFORE BE IT ORDAINED** by the Governing Body of the Borough of Red Bank that Chapter VIII, "Parking Lots and Handicapped Spaces", Section 8-2.6, " Permit Parking", be amended and supplemented as follows ( ~~strikeouts~~ denote deletions and underline additions) :

**8-2.6 Permit Parking.**

- a. *Permits Authorized.* Parking or standing a vehicle in a designated space in a permit parking zone shall be lawful upon purchasing of a permit. Upon paying the proper fee, a permit identification will be issued and must be displayed on the vehicle when parked in the permit parking zone as described in Schedule II.
- b. *Permit Fees.* Parking fees for permit parking shall be as follows:
  1. In all permit parking spaces.
    - (a) For a thirty-day permit: \$135.
    - (b) For a three-month permit: \$200.
    - (c) For a six-month permit: \$400.
- c. *Permit Signage.* All permit parking signage on Borough owned property shall be designed and approved by the Borough and be uniform in nature. The permit parking signage shall clearly and simply designate the days and hours when the permit parking is in effect and the days and hours when the general public may use the spaces. All existing permit signs that do not meet the design standards required by the Borough shall be removed and replaced with a uniform sign.

**SECTION TWO:** Any ordinances or portions thereof which are inconsistent with the provisions of this Ordinance are hereby repealed as of the effective date of this Ordinance. All other provisions of the "Parking Lots and Handicapped Parking Spaces" Ordinance are ratified and remain in full force and effect.

**SECTION THREE:** If any provision of this Ordinance or the application of such provision to any person or circumstance is declared invalid, such invalidity shall not affect the other provisions or applications of this Ordinance which can be given effect, and to this end, the provisions of this Ordinance are declared to be severable.

**SECTION FOUR:** This Ordinance shall take effect immediately upon its passage and adoption according to law.
