ORDINANCE OF THE BOROUGH OF RED BANK, MONMOUTH COUNTY
AMENDING CHAPTER XX "WATER AND SEWER", SECTIONS 20-3 "WATER
DEPARTMENT" AND 20-4 "SEWER DEPARTMENT" OF THE REVISED GENERAL
ORDINANCES OF THE BOROUGH OF RED BANK

Councilman DuPont offered the following ordinance and moved its introduction on final reading:

BE IT ORDAINED by the Governing Body of the Borough of Red Bank that Chapter XX "Water and Sewer", of the revised General Ordinances of the Borough of Red Bank is amended and supplemented as follows:

SECTION ONE: Section 20-3 "Water Department", Subsection 20-3.1 "Water Rates" is amended and supplemented to read as follows:

20-3.1 Water Rates. The minimum water rates to be charged per quarter, by the Borough shall be as follows (deletions ~~stricken~~, additions underlined):

a.	Water Rates Size of Meter	Customer Charge Per Quarter
	5/8" and 3/4"	\$ 44.00
	1"	88.00
	1-1/2"	132.00
	2"	220.00
	3" and Larger	352.00

Water Charge

In addition to the Customer's Charge, a charge will be made for all water used, as registered by the meter, at the following rate:

Rate Per 100 Cubic Feet

\$5.32

Rate Per 1000 Gallons

\$7.11

(100 cubic feet = 748 gallons)

SECTION TWO: Section 20-4 "Sewer Department", subsection 20-4.4 "Fee" is amended and supplemented to read as follows:

20-4.4 Sewer Service Fees With Water Service. Every owner or occupant of premises served by the sewer or drain system of the Borough shall pay quarterly, each year, on a cycle billing basis, a charge for the use thereof of one hundred twenty-five (125%) percent of the amount of said owners or occupants water charge.

SECTION THREE: Section 20-4 "Sewer Department", subsection 20-4.5 "Sewer Service Fees Without Water Service" is amended and supplemented to read as follows:

20-4.5 Sewer Service Fees Without Water Service. For all premises not served by the Borough water system, the sewer charge shall be based upon the actual cubic feet of water consumed at a rate of six dollars and sixty-six (\$6.66) cents per one hundred (100) cubic feet or eight dollars and ninety (\$8.90) cents per one thousand (1.000) gallons. Consumption information will be supplied by the water purveyor supplying the premises.

SECTION FOUR: Any ordinances or portions thereof which are inconsistent with the

provisions of this Ordinance are hereby repealed as of the effective date of this Ordinance. All other provisions of Chapter XX "Water and Sewer" are ratified and remain in full force and effect.

SECTION FIVE: If any provision of this Ordinance or the application of such provision to any person or circumstance is declared invalid, such invalidity shall not affect the other provisions or applications of this Ordinance which can be given effect, and to this end, the provisions of this Ordinance are declared to be severable.

SECTION SIX: This Ordinance shall take effect immediately upon its passage and adoption according to law.
